This public meeting was held at South Shore Elementary School (1376 Fairfield Loop Road, Crownsville, Maryland) and started at approximately 6:00 p.m. on Thursday, October 23, 2025.

Melissa Harlinski, Department of Public Works (DPW) Project Manager, began by introducing herself and the project team and stating the purpose of the meeting. The Project Team includes Erica Jackson, Department of Recreation and Parks (DRP) Deputy Director, Bruce Bruchey, DRP Chief of Planning and Construction; Alison Woodfield DRP Chief of Natural & Cultural Resources, and Megan Barniea, BayLand Consultants & Designers, Inc. Project Manager.

Erica then discussed project background and purpose, and the goal to expand public water access on the Severn River. Erica reviewed the concepts that were developed and presented during spring 2022, a revised concept that was presented in 2023 based on comments solicited in 2022, and then explained the revised concept was used as a starting point for the current design.

Erica reviewed anticipated utilization for the proposed water access park and then summarized stakeholder feedback from the current concept that was presented in September 2025. Erica then turned the meeting over to BayLand to present the Concept Design for the Valentine Creek Park Water Access project. Megan Barniea presented the existing conditions for the project site and then described the changes from the 2023 concept to the current concept design.

Megan continued the presentation with a discussion of the proposed park elements, including access road improvements, the parking lot and stormwater management, minimization of environmental impacts, connectivity to existing trail system, and water access improvements. Megan followed with the Community Meeting points per required per Code § 17-2-107 and the required permits and approvals for the project.

Megan then turned the meeting over to Erica Jackson to discuss the potential water access amenity options and anticipated operations plan. Erica then turned the meeting back over to Megan Barniea to discuss the potential alternative access points for a public water access facility and summarize why they are not feasible. Megan then turned the meeting over to Melissa Harlinski to review the traffic concerns that have been raised by stakeholders and the County's discussions with the Bureau of Highways (BOH). Melissa then turned the meeting back over to Megan to summarize how the proposed concept addresses comments and concerns raised by stakeholders. Megan then turned the meeting back over to Melissa Harlinski to facilitate the questions and answers period of the meeting.
