And be it further resolved, That the following question is adopted for submittal to the qualified voters of the County at the general election in November 2026 for their adoption or rejection:

"To amend the Anne Arundel County Charter to create the Office of Multi-Cultural Affairs administered by a Multi-Cultural Affairs Officer, to advance the political, social, and economic inclusion of diverse communities and promote their access to government services and programs."

And be it further resolved, That this question shall be designated as Question "__" on the ballot at the General Election in November 2026.

And be it further resolved, That if the majority of qualified votes cast in the election are for the Charter Amendment, this amendment shall stand adopted from and after the 30th day following the election.
