

# SUMMER SACC 2026

**INFORMATION:** The theme for the 2026 Summer SACC programs is ***Worlds of Wonder***. This summer, we are excited to provide arts and crafts, games, activity stations, outdoor play, STEM and Literacy activities. This program will also include two sessions with field trips, and four sessions with on-site traveling enrichments. ☺

## REGISTRATION/REFUND POLICIES:

Please be aware that there is a minimum & a maximum registration for each center, and registration is on a first-come, first-served basis.

- **Summer Registration** for the Rec & Parks Summer programs will officially open to the public online on **February 9, 2026 at 8am**.  
**Early Bird Registration for current school year child care families ONLY is February 6, 2026 from 8am-11:59pm.**
  - A non-refundable and non-transferrable deposit of \$25 per child, per weekly session is required at the time of registration. This \$25 deposit will be applied toward the total weekly fee. See below Fee Schedule for details.

  - **NEW** participants to Rec & Parks Child Care are urged to create an account with us online prior to registration day. This will help to ease your online wait times when you log in to register on February 9<sup>th</sup> for these very popular programs!
- **Summer Fee Schedule:** You must pay for the summer program on a bi-weekly basis ahead of service. If your needs should change during the summer and your family no longer needs care, you must email us at [sacc@aacounty.org](mailto:sacc@aacounty.org) to withdraw.
- **Refund Policy:** A \$25 processing fee will be assessed on all refunds. 10 business days' notice is required for all summer refunds. 10 business days' notice is also required for all requests to transfer fees between summer weeks. Weekly payments may be transferred between summer weeks ONE time ONLY. All refund requests for medical reasons must be accompanied by a physician's note and are handled on a case-by-case basis. All refund requests must be made in writing to the Child Care Administrative Office.

## ELIGIBILITY:

- **AGES:** Children MUST be **entering 1<sup>st</sup> through 6<sup>th</sup> grade for the 2026-2027 school year** to be eligible to attend Summer SACC.
- **STATE MANDATED FORMS:** Every child MUST have the State mandated forms completed and on file at the site prior to their first day of attending. **No one will be permitted to attend without this information on file. Health Inventory requires a physician's signature.**
  - **NEW Participants:** You can download the **Required Forms for Admission** on our website.
  - **CURRENT School Year SACC Participants:** Paperwork for current SACC participants will be shared from your school year site to your summer site. Current School Year parents will be asked to update forms by the staff on site.
- **TOILETING:** Children must be toilet trained. Your child must be able to be self-directed & self-sufficient in the restroom and able to care for their own hygiene needs. **Please contact our office at 410-222-7856, ext.0 to schedule a meeting to discuss toileting assistance if your child has a diagnosed special need.**
