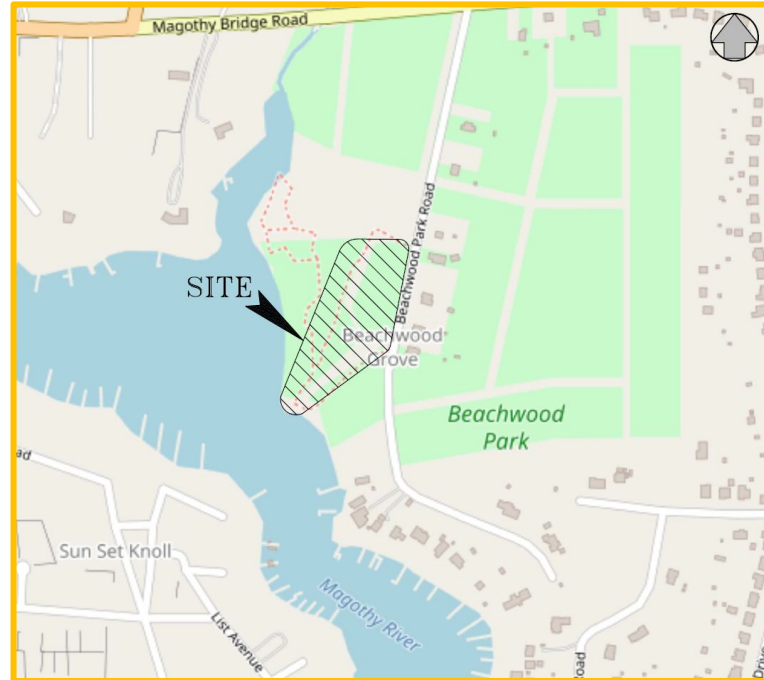

  - Cartop Boat Launch
  - Fishing, Natural Area and Trails
  - Restroom

- Critical Area Designation: Resource Conservation Area (RCA) Limited Development Area (LDA) and Expanded Buffer
- Impacts of Proposed Development on Environmental Features: Critical Area, Non-tidal Wetlands, Steep Slopes, Tidal Waters, and Specimen Trees

- Schematic Design (30%) – Winter 2026  We are here
- Federal & State Permitting – Spring 2026 through Fall 2026
- Design Development (60%) – Spring/Summer 2026
- County Permitting & Construction Documents – Fall 2026/Winter 2027
- Construction – Spring 2027
