A BILL ENTITLED

1 AN ORDINANCE concerning: Zoning – Conditional Use Requirements – Licensed
2 Dispensaries of Cannabis

4 FOR the purpose of requiring a licensed dispensary be located a certain distance from
5 certain facilities; requiring a licensed dispensary be located a certain distance from
6 property with a residential use; requiring a licensed dispensary be a certain distance
7 from any other licensed dispensary; and generally relating to zoning.

12 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
13 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

ARTICLE 18. ZONING

TITLE 10. REQUIREMENTS FOR CONDITIONAL USES

18-10-145. Licensed dispensaries, growers and processors of cannabis.

21 (a) Dispensary. A licensed dispensary of cannabis, as defined in State law and
22 regulations, shall comply with all of the following requirements.

1 (6) THE LOT LINE OF THE PROPERTY MAY NOT BE WITHIN 500 FEET OF THE CLOSEST
2 LOT LINE OF A PRE-EXISTING SCHOOL, PLAYGROUND, RECREATION CENTER, LIBRARY,
3 PUBLIC PARK, PLACE OF WORSHIP, LICENSED CHILD CARE CENTER, OR REGISTERED
4 FAMILY CHILD CARE HOME.

5
6 (7) THE LOT LINE OF THE PROPERTY MAY NOT BE LOCATED WITHIN 100 FEET OF
7 THE CLOSEST LOT LINE OF A PROPERTY WITH A RESIDENTIAL USE.

8
9 (8) THE LOT LINE OF THE PROPERTY MAY NOT BE WITHIN A HALF MILE OF THE
10 CLOSEST LOT LINE OF ANOTHER DISPENSARY.

12 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days
13 from the date it becomes law.
