1 RESOLUTION approving conditional appropriation of an unappropriated grant to the
2 Grants Special Revenue Fund – Maryland Department of Transportation, Maryland Transit
3 Administration – Electric/Hybrid Buses, \$900,551

5 WHEREAS, § 4-11-114(c) of the County Code allows appropriation of revenue
6 from a grant not included in an appropriation ordinance, as well as any County
7 matching funds, to the Grants Special Revenue Fund if certain conditions are met;
8 and

10 WHEREAS, the conditions for the conditional appropriation for unappropriated
11 grant revenues are: (1) an approved budget and communication that confirms that
12 the funds are available for expenditure by the County; (2) availability of sufficient
13 appropriated funds for any required County match; and (3) presentation of a
14 Resolution to the County Council to approve the appropriation, and three or more
15 members of the Council request that the Resolution be heard at the next scheduled
16 hearing of the County Council or such request is not made within five business days
17 of being presented with the Resolution; and

19 WHEREAS, the Office of Transportation has received an award letter from the
20 Maryland Department of Transportation, Maryland Transit Administration for the
21 acquisition of Electric/Hybrid Buses in the amount of \$900,551, the Controller is
22 satisfied that the grant funds are available for expenditure by the County, and
23 County matching funds in the amount of \$180,110 are available and appropriated;

26 WHEREAS, by this Resolution, the County Executive is requesting appropriation
27 of Electric/Hybrid Buses funds from Maryland Department of Transportation,
28 Maryland Transit Administration in the amount of \$900,551, to be administered by
29 the Office of Transportation; now, therefore, be it

31 *Resolved by the County Council of Anne Arundel County, Maryland, That, the*
32 *provisions of § 4-11-114(c) of the County Code having been met, the County Council*
33 *approves the appropriation of funds from the Maryland Department of Transportation,*
34 *Maryland Transit Administration for Electric/Hybrid Buses in the amount of \$900,551 to*
35 *the Grants Special Revenue Fund, as follows:*
