## A BILL ENTITLED

1 AN ORDINANCE concerning: the issuance, sale and delivery of Anne Arundel County,  
2 Maryland general obligation bonds and bond anticipation notes  
3

4 FOR the purpose of authorizing the issuance by Anne Arundel County, Maryland (the  
5 “County”) of bond anticipation notes in an amount to be outstanding at any time not in  
6 excess of Nine Hundred Million Dollars (\$900,000,000) and bonds in an amount not  
7 exceeding Two Billion Ninety Million Three Hundred Seventy-One Thousand Seven  
8 Hundred Fifty-Five Dollars (\$2,090,371,755) in order to finance in whole or in part the  
9 construction of capital projects set forth in the capital budget of the County for the  
10 fiscal year ending June 30, 2027, or in such capital budgets for prior fiscal years, or  
11 usable portions thereof; authorizing the issuance by the County of refunding bonds to  
12 refund some or all of the outstanding bond issues of the County listed on Exhibit II  
13 attached hereto and incorporated herein in an aggregate principal amount not to exceed  
14 120% of the aggregate principal amount of the outstanding bonds to be refunded,  
15 subject to the requirement that debt service savings shall be achieved in connection  
16 with any such refunding; authorizing the County to borrow money and incur  
17 indebtedness otherwise authorized to be borrowed and incurred hereunder in the form  
18 of bonds or bond anticipation notes by obtaining a loan or loans from the Maryland  
19 Water Infrastructure Financing Administration pursuant to and in accordance with  
20 Sections 9-1601 through 9-1622, inclusive, of the Environment Article of the  
21 Annotated Code of Maryland (2014 Replacement Volume and 2025 Supplement) for  
22 the public purpose of financing a portion of the costs of acquiring, constructing and  
23 equipping certain wastewater facilities and water supply systems; providing for the  
24 execution and delivery by the County of a loan agreement and bond to evidence any  
25 such loan; reaffirming and clarifying the guides and standards relating to the borrowing  
26 of money to finance such capital projects heretofore adopted; listing the capital projects  
27 to be financed in whole or in part from the proceeds of sale of the bonds hereby  
28 authorized, or usable portions thereof, estimated costs and probable useful lives thereof;

1 showing compliance with the limitations on the power of the County to incur  
2 indebtedness; providing for essential flexibility in the financing of such capital projects  
3 and the issuance of such bonds by authorizing such bond anticipation notes to be repaid  
4 from the proceeds of the sale of such bonds; prescribing the procedure for the issuance  
5 and sale of such bond anticipation notes and bonds; empowering the County Executive  
6 of the County (the "County Executive"), or the Chief Administrative Officer of the  
7 County (the "Chief Administrative Officer") if authorized by the County Executive,  
8 subject to such guides and standards, to determine the time and method of sale of such  
9 bond anticipation notes and refunding bonds, which sale may be a private (negotiated)  
10 sale or a public sale, and the time, place, and procedure for the public sale of such bonds  
11 other than refunding bonds; empowering the County Executive, or the Chief  
12 Administrative Officer if authorized by the County Executive, subject to such guides  
13 and standards, to determine the forms of such bonds and to determine the forms of such  
14 bond anticipation notes; empowering the County Executive, or the Chief  
15 Administrative Officer if authorized by the County Executive, to provide for or  
16 determine the private (negotiated) sale of any loan agreement or bond to the Maryland  
17 Water Infrastructure Financing Administration, the form or forms thereof and other  
18 details with respect thereto and to the sales thereof; providing that such bond  
19 anticipation notes may be issued as notes in the nature of commercial paper and, in  
20 such event, authorizing the County Executive, or the Chief Administrative Officer if  
21 authorized by the County Executive, to determine various matters and to take various  
22 actions in connection with such issuance; providing that such bonds and bond  
23 anticipation notes may be issued as variable rate demand or similar obligations and, in  
24 such event, authorizing the County Executive, or the Chief Administrative Officer if  
25 authorized by the County Executive, to determine various matters and to take various  
26 actions in connection with such issuance; covenanting to issue, upon its full faith and  
27 credit, the bonds in anticipation of the sale of which any bond anticipation notes are  
28 issued when, and as soon as, the reason for deferring the issuance thereof no longer  
29 exists, to pay the principal of and interest on (to the extent such is not otherwise paid)  
30 such notes from the proceeds of such bonds and that, if the County shall be unable to  
31 issue and sell its bonds in an amount sufficient to pay the principal of and interest on  
32 any notes issued, then to appropriate sufficient revenues in each fiscal year following  
33 the issuance of such bond anticipation notes to pay the maturing principal thereof and  
34 the interest thereon to the extent not otherwise paid; covenanting to appropriate  
35 sufficient revenues in each fiscal year following the issuance of such bonds to pay the  
36 maturing principal thereof and the interest thereon and to meet such appropriation  
37 either by revenues derived from self-liquidating projects or from the proceeds of ad  
38 valorem taxes, or a combination of the foregoing; pledging the full faith and credit of  
39 the County, to the payment of the bonds and bond anticipation notes issued hereunder  
40 and the interest thereon, when due; providing that the pledge of the taxing power to  
41 secure such bonds and bond anticipation notes shall be subject to the limitation imposed  
42 by Section 710(d) of the Anne Arundel County Charter, except in the case where  
43 refunding bonds are issued to refund bonds secured by the pledge of the full faith and  
44 credit and unlimited taxing power of the County; covenanting that the proceeds of such  
45 bonds and bond anticipation notes, or any money which may be deemed to be proceeds,  
46 will not be used in a manner to cause such bonds to be arbitrage bonds; canceling,  
47 rescinding, and repealing authority to issue certain bonds only to the extent such  
48 authority has not been previously exercised under Bill No. 55-25, as amended, and  
49 ratifying, confirming and validating the previous authorization, issuance, sale and

1 delivery of bonds and bond anticipation notes pursuant to applicable authority; ratifying  
2 and authorizing the issuance of Shore Erosion Control Construction Loans pursuant to  
3 and in accordance with Sections 8-1001 to 8-1008, inclusive, of the Natural Resources  
4 Article of the Annotated Code of Maryland (2023 Replacement Volume and 2025  
5 Supplement); and generally providing for the consolidation and authorization of a  
6 borrowing program for the County, and matters generally related thereto.

7  
8 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
9 That in connection with the issuance by Anne Arundel County, Maryland (the “County”)  
10 of the bonds hereinafter authorized, (i) the STATEMENT OF POLICY adopted by Bill  
11 No. 70-66 is hereby reaffirmed as it applies to the issuance of the bonds authorized hereby,  
12 and as clarified herein, and restated below as so clarified, for the information of the public  
13 and for the guidance of the County Executive of the County (the “County Executive”) or  
14 the Chief Administrative Officer of the County (the “Chief Administrative Officer”), as the  
15 case may be, in exercising the authority hereby conferred on them, and (ii) the following  
16 FINDINGS OF FACT are hereby adopted for the purpose of demonstrating compliance  
17 with the requirements and limitations of the Anne Arundel County Charter (the “County  
18 Charter”) on the borrowing of money and the issuance of bonds by the County, in evidence  
19 thereof:

#### 20 21 **STATEMENT OF POLICY**

22  
23 (1) It is essential that the County continue to provide, in timely fashion, the public  
24 facilities necessary to serve its population, which has increased significantly in recent  
25 years, while at the same time retaining and supporting substantial rural and agricultural  
26 elements of the County’s economy which enable the County to enjoy the benefits of a  
27 balanced and diverse economy. All or a portion of the cost of such facilities will have to  
28 be financed through the borrowing of money by the County on a reasonably long-term  
29 basis in order that the burden of such cost may be equitably apportioned among present  
30 and future taxpayers. However, it is equally essential that the credit standing of the County  
31 be preserved and, if possible, improved to the end that the cost of borrowing money by the  
32 County will not be unduly burdensome. To aid in achieving these basic objectives, the  
33 County Executive or the Chief Administrative Officer, as the case may be, shall, to the  
34 maximum extent possible, exercise the authority hereby conferred upon them within the  
35 following guidelines as well as within the fixed limitations prescribed herein and in the  
36 County Charter.

37  
38 (2) Sales of bonds hereunder shall be spaced at least six (6) months apart when  
39 practicable; provided, however, that bonds may be sold hereunder at such other intervals  
40 as the County Executive, or the Chief Administrative Officer, as the case may be, may  
41 deem advisable due to financial or market conditions prevailing at the time.

42  
43 (3) To provide an adequate flow of funds for capital projects, to limit amounts borrowed  
44 to the costs incurred for such projects, and to facilitate the selection of the most  
45 advantageous times for the sale of bonds, bond anticipation notes may be sold for such  
46 projects from time to time, repayable from the proceeds of the appropriate series of such  
47 bonds, when issued.

1 (4) The authority hereby conferred shall be so exercised that the estimated maximum  
2 annual debt service obligation resulting therefrom plus current debt service payable by the  
3 County on outstanding obligations does not exceed an amount equal to twenty percent  
4 (20%) of the estimated net amount of all direct and indirect revenues of the County for the  
5 current fiscal year, including utility revenues, calculated by subtracting from gross  
6 revenues all debt service withheld or to be withheld by the State or any agency thereof  
7 during such fiscal year.

8  
9 (5) All bonds issued and sold by the County hereunder shall be unconditional general  
10 obligation bonds of the County within the limitations of indebtedness set forth below as  
11 prescribed by the County Charter and the ordinances enacted pursuant thereto. Before any  
12 such bonds are issued for revenue producing projects of water or wastewater utilities, the  
13 County Executive, or the Chief Administrative Officer if authorized by the County  
14 Executive, shall determine that the estimated revenues of such projects, or the actual and  
15 estimated revenues of such projects and the utilities of which they are a part, are, or will  
16 be, sufficient to pay the cost of operation and maintenance of such projects and the  
17 maturing principal of and interest on all indebtedness incurred with respect thereto,  
18 including such bonds. The authorization herein of general obligation bonds of the County  
19 for revenue producing projects shall not be construed to preclude the County Council from  
20 authorizing in the future the issuance of bonds payable solely from the revenues of similar  
21 projects or utilities.

22  
23 (6) Pursuant to resolutions adopted by the County Council from time to time, as the  
24 same may be amended and supplemented, the County has adopted a debt management  
25 policy (the "Debt Management Policy") that shall constitute the local debt policy of the  
26 County required by Section 17-207 of the Local Government Article of the Annotated Code  
27 of Maryland (2013 Replacement Volume and 2025 Supplement). The validity of any  
28 proceedings or action taken pursuant to this Ordinance shall not be limited by or otherwise  
29 impaired by the Debt Management Policy.

30  
31 FINDINGS OF FACT

32  
33 I

34  
35 With respect to the maximum amount of bonds and bond anticipation notes of the  
36 County hereinafter authorized, it is hereby found and determined that such amount is within  
37 applicable debt limitations, as follows:

38  
39 (1) With regard to the General County Debt Limitation (defined below):

40  
41 (a) That the taxable assessed value of all real and personal property in the County,  
42 subject to unlimited county taxation (except by application of Section 710(d) of the County  
43 Charter) as of April 30, 2026 is \$117,642,409,633 consisting of an assessable basis of real  
44 property of \$114,501,011,913 and an assessable basis of personal property and operating  
45 real property described in Section 8-109(c) of the Tax-Property Article of the Annotated  
46 Code of Maryland (2019 Replacement Volume and 2025 Supplement) of \$1,410,051,420  
47 and \$1,731,346,300, respectively, and, in each case, is expected to be no less than such  
48 amount for the fiscal year ending June 30, 2027.

1 (b) That, in accordance with Section 10-203 of the Local Government Article of  
2 the Annotated Code of Maryland (2013 Replacement Volume and 2025 Supplement), and  
3 in accordance with Section 4-10-101(a) of Article 4, Finance, Taxation, and Budget of the  
4 Anne Arundel County Code, the aggregate amount of the indebtedness of the County  
5 outstanding at one time shall not exceed (I) 5.2% of the assessable basis of real property;  
6 (II) 13% of the County's assessable basis of personal property; and (III) 13% of the  
7 operating real property described in Section 8-109(c) of the Tax-Property Article of the  
8 Annotated Code of Maryland (2019 Replacement Volume and 2025 Supplement) (the  
9 "General County Debt Limitation"); provided, however that (i) tax anticipation notes or  
10 other evidences of indebtedness having a maturity not in excess of twelve months,  
11 (ii) bonds or other evidences of indebtedness issued or guaranteed by the County payable  
12 primarily or exclusively from taxes levied in or on, or other revenues of, special taxing  
13 districts and (iii) bonds or other evidences of indebtedness issued for self-liquidating and  
14 other projects payable primarily or exclusively from the proceeds of assessments or charges  
15 for special benefits or services, including bonds or other evidences of indebtedness issued  
16 for water or wastewater facilities, are not subject to, or required to be included as bonds or  
17 evidences of indebtedness in computing or applying the General County Debt Limitation.  
18

19 (c) That the maximum amount of outstanding debt permitted under the General  
20 County Debt Limitation is \$6,362,434,323 as of April 30, 2026, and is expected to be no  
21 less than such amount for the fiscal year ending June 30, 2027.  
22

23 (d) That the total outstanding bonded debt of the County subject to the General  
24 County Debt Limitation is \$1,805,870,000 as of April 30, 2026, including, for purposes of  
25 this presentation, the outstanding Special Obligation Refunding Bonds (Arundel Mills  
26 Project), Series 2014, the outstanding Special Obligation Refunding Bonds (National  
27 Business Park Project), Series 2014, the outstanding Tax Increment Refunding Bonds  
28 (Nursery Road Project), Series 2014, the outstanding Special Obligation Refunding Bonds  
29 (National Business Park - North Project), Series 2018, and the outstanding Special  
30 Obligation Refunding Bonds (Village South at Waugh Chapel Project), Series 2018.  
31

32 (e) That the permissible borrowing capacity is \$4,556,564,223 as of April 30, 2026.  
33

34 (f) That the bonds authorized by this Ordinance subject to the General County Debt  
35 Limitation aggregate \$1,424,124,504 (for the purposes of stating such amount, the amount  
36 of Refunding Bonds (hereinafter defined) authorized by this Ordinance has been reduced  
37 by the aggregate principal amount of bonds authorized to be refunded, as required by  
38 Section 19-207 of the Local Government Article of the Annotated Code of Maryland (2013  
39 Replacement Volume and 2025 Supplement) and, in addition, the aggregate amount of  
40 bonds authorized to be refunded is determined as of the date set forth on Exhibit II attached  
41 hereto and incorporated herein by this reference).  
42

43 (g) That in stating the total outstanding debt in (1)(d) above, debt in the amount of  
44 \$53,298,938 for self-liquidating solid waste projects, \$178,566,161 for dedicated revenue  
45 watershed protection and restoration projects and \$3,047,835 for impact fee revenue  
46 projects was included, and in stating the debt subject to the General County Debt Limitation  
47 in (1)(f) above, debt in the amount of \$22,115,104 for self-liquidating solid waste projects,  
48 \$216,681,290 for dedicated revenue watershed protection and restoration projects, as well  
49 as \$1,074,618,071 for impact fee revenue projects was included; such presentation of debt

1 for self-liquidating solid waste projects, dedicated revenue watershed protection and  
2 restoration projects, and impact fee revenue projects is made herein to provide a  
3 conservative statement of indebtedness that evidences compliance with the General County  
4 Debt Limitation.

5  
6 (2) With regard to the Water and Wastewater Debt Limitation (as defined below):

7  
8 (a) That the taxable assessed value of all real and personal property within the  
9 Sanitary District of Anne Arundel County subject to unlimited County taxation (except by  
10 application of Section 710(d) of the County Charter) as of April 30, 2026 is  
11 \$108,380,041,338, consisting of an assessable basis of real property of \$105,412,744,138  
12 and an assessable basis of personal property and operating real property described in  
13 Section 8-109(c) of the Tax-Property Article of the Annotated Code of Maryland (2019  
14 Replacement Volume and 2025 Supplement) of \$1,336,723,700 and 1,630,573,500,  
15 respectively, and, in each case is expected to be no less than such amount for the fiscal year  
16 ending June 30, 2027.

17  
18 (b) That bonds of the County issued for water and wastewater facilities, which are  
19 payable primarily from assessment of charges for special benefits and services are  
20 exempted from the limitations outlined in subparagraph (1)(b) above. Section 4-10-103(d)  
21 of Article 4, Finance, Taxation, and Budget of the Anne Arundel County Code, limits the  
22 amount of such bonds, after crediting applicable Sinking Fund balances, which may be  
23 outstanding to not greater than (I) 5.6% of the County's assessable basis of real property;  
24 (II) 14% of the County's assessable basis of personal property; and (III) 14% of the  
25 operating real property described in Section 8-109(c) of the Tax-Property Article of the  
26 Annotated Code of Maryland (2019 Replacement Volume and 2025 Supplement) (the  
27 "Water and Wastewater Debt Limitation").

28  
29 (c) That the maximum amount of outstanding debt permitted under the Water and  
30 Wastewater Debt Limitation is \$6,318,535,280 as of April 30, 2026, and is expected to be  
31 no less than such amount for the fiscal year ending June 30, 2027.

32  
33 (d) That the total outstanding bonded debt of the County subject to the Water and  
34 Wastewater Debt Limitation is \$900,738,067 as of April 30, 2026.

35  
36 (e) That the permissible borrowing capacity is \$5,417,797,213 as of April 30, 2026.

37  
38 (f) That the bonds authorized by this Ordinance subject to the Water and  
39 Wastewater Debt Limitation aggregate \$1,196,510,864 (for the purposes of stating such  
40 amount, the amount of Refunding Bonds authorized by this Ordinance has been reduced  
41 by the aggregate principal amount of bonds authorized to be refunded, as required by  
42 Section 19-207 of the Local Government Article of the Annotated Code of Maryland (2013  
43 Replacement Volume and 2025 Supplement) and in addition, the aggregate amount of  
44 bonds authorized to be refunded is determined as of the date set forth on Exhibit II attached  
45 hereto).

1 (1) The bond anticipation notes authorized by Section 6 hereof and bonds authorized  
2 by Section 2 hereof are to be issued to finance in whole or in part certain of the capital  
3 projects or classes of projects included in the capital budget for the fiscal year 2027, or in  
4 capital budgets for prior fiscal years. With respect to such projects, the amount of borrowed  
5 funds to be expended thereon, together with the funds shown as available from other  
6 sources, are estimated to be sufficient to complete usable portions thereof, but if any such  
7 funds from other sources, intended to defray in part the cost of any such project, shall  
8 become unavailable, the County Executive shall either (i) direct the abandonment of any  
9 such project if, in his judgment, the unavailability of funds from other sources would render  
10 any such project unusable or (ii) recommend an appropriate amendment of the Capital  
11 Budget, as provided in Sections 711 and 716 of the County Charter. The balances  
12 remaining to the credit of a completed or abandoned capital project for which bond  
13 anticipation notes or bonds have been issued shall be available for appropriation by the  
14 County Council in a subsequent capital budget, as provided in the County Charter.

15  
16 (2) No series of bond anticipation notes authorized by Section 6 hereof or bonds  
17 authorized by Section 2 hereof shall be issued hereunder with a final maturity date  
18 extending beyond the expiration of the probable useful life, or the average probable useful  
19 lives, of the capital project or projects for which such series of bond anticipation notes or  
20 bonds are issued, accounting from the date of issue of such series of bond anticipation notes  
21 or bonds. The provisions of Section 2(5) hereof shall apply to the consolidation of series  
22 of bonds as permitted therein.

23  
24 (3) No series of Refunding Bonds authorized by Section 3 hereof shall be issued  
25 hereunder with a final maturity date extending beyond the earliest to occur of (i) the  
26 thirtieth (30<sup>th</sup>) anniversary of the date of issuance of the bonds to be refunded from the  
27 proceeds of the Refunding Bonds being issued and (ii) the latest maturity date that would  
28 have been permitted for the Refunded Bonds (hereinafter defined). Prior to the delivery of  
29 any Refunding Bonds hereunder, the County Executive, or the Chief Administrative  
30 Officer if authorized by the County Executive, shall deliver a written certificate stating that  
31 the maturity schedule of any series of Refunding Bonds issued hereunder complies with  
32 the requirements set forth in this paragraph and setting forth the facts upon which such  
33 conclusion is based.

34  
35 (4) The table attached to this Ordinance as Exhibit I and incorporated herein by this  
36 reference lists (a) the capital projects, which appear in the capital budget of the County for  
37 fiscal year 2027, or in the capital budgets for prior fiscal years, which are to be financed in  
38 whole or in part with the proceeds of bond anticipation notes authorized by Section 6  
39 hereof, bonds authorized by Section 2 hereof, with the reallocation of balances remaining  
40 to the credit of completed or abandoned capital projects for which bond anticipation notes  
41 or bonds were previously issued or for which funds were previously provided from other  
42 sources or bond premium, consisting of net bond proceeds from the sale of bonds sold at a  
43 price above par, (b) the estimated cost of a usable portion of each project or class of  
44 projects, including capitalized interest on borrowed funds as herein authorized, (c) the  
45 portion of such costs of each such project or class of projects to be financed hereunder,  
46 (d) the source or sources of funds to finance the balance of the cost of each such project or  
47 class of projects, (e) and the probable useful life of each such project or the average of the  
48 probable useful lives of each such class of projects. Totals listed in Exhibit I may not foot  
49 due to rounding. Further, the first group of projects included in Exhibit I are those which

1 are not revenue producing, and the second group of projects are those which it is estimated  
2 will generate or have available net revenues sufficient to pay all or a portion of the debt  
3 service on the borrowing therefor. In lieu of issuing all or any part of the bonds or bond  
4 anticipation notes authorized to be issued by Sections 2 and 6, respectively, of this  
5 Ordinance to finance all or part of a capital project, the County Executive, or the Chief  
6 Administrative Officer if authorized by the County Executive, may, at his discretion apply  
7 to such project balances remaining to the credit of any completed or abandoned capital  
8 projects for which bond anticipation notes or bonds were previously issued or for which  
9 funds were previously provided from other sources, but only to the extent that bond  
10 anticipation notes or bonds are authorized to be issued therefor in this Ordinance, such  
11 expenditure of such balances or bond premium being within the appropriation established  
12 for such project in the applicable capital budget or budgets; provided, however, that such  
13 balances or bond premium shall not be applied in a manner that would adversely affect the  
14 exemption from federal income taxation of the interest on any bond anticipation notes or  
15 bonds to which such balances are attributable.

16  
17 (5) Bond premium generated from the issuance of any County bonds shall be expended  
18 on capital improvements in accordance with Section 720(b) of the County Charter and as  
19 otherwise prescribed by law.

20  
21 (6) Participation by the County in any county transportation bonds issued by the  
22 Maryland Department of Transportation shall not result in any reduction in the amount of  
23 bonds or bond anticipation notes authorized and deemed to be unissued under this  
24 Ordinance.

25  
26 SECTION 2. *And be it further enacted,* That for the purpose of paying the portion of  
27 the cost of the capital projects described in Section 1 hereof and Exhibit I hereto, to be paid  
28 from borrowed funds, or for the purpose of redeeming outstanding bond anticipation notes  
29 or bond anticipation notes issued hereunder, the issuance and sale by the County, of not  
30 exceeding Two Billion Ninety Million Three Hundred Seventy-One Thousand Seven  
31 Hundred Fifty-Five Dollars (\$2,090,371,755) aggregate principal amount of general  
32 obligation bonds of the County is hereby authorized. To the extent required for such  
33 purposes, the bonds hereby authorized shall be sold prior to June 30, 2029, in accordance  
34 with the guides and standards set forth in Section 1 hereof, except that any such bonds may  
35 be sold subsequent to such date if required to redeem, prepay or pay at maturity bond  
36 anticipation notes. Such bonds shall be issued as registered bonds without coupons in the  
37 denomination of five thousand dollars (\$5,000) or any integral multiple thereof within the  
38 limits of specified serial maturities.

39  
40 (1) Except as otherwise provided in this Ordinance, the bonds authorized by this  
41 Section 2 shall be sold at a sale price at, above, or below par, plus accrued interest to the  
42 date of delivery, and only after first soliciting competitive bids at public sale in accordance  
43 with the provisions of Section 5 hereof. Such bonds are hereby specifically exempted from  
44 the provisions of Sections 19-205 and 19-206 of the Local Government Article of the  
45 Annotated Code of Maryland (2013 Replacement Volume and 2025 Supplement).

46  
47 (2) Subject to the provisions of subsection (5) of this Section, such bonds shall be issued  
48 in series intended to identify the public purpose or purposes for which each series is issued.  
49 On each bond, there shall appear the words “ \_\_\_\_\_ Series, 20\_\_ ” and in the blank

1 space preceding the word "Series," there shall be inserted the par amount of the series plus  
2 the public purpose of such series, e.g., "Board of Education," "Library," "Recreation and  
3 Parks," "Water and Sewer" and "Watershed Protection and Restoration." The County  
4 Executive, or the Chief Administrative Officer if authorized by the County Executive, may  
5 incorporate such additional designations in the name of the series as they deem necessary  
6 or convenient to distinguish two or more series issued for the same purpose within the same  
7 calendar year.

8  
9 (3) The bonds of each series shall be dated on or prior to the date of the delivery of  
10 such series and shall be numbered as determined by the County Executive, or the Chief  
11 Administrative Officer if authorized by the County Executive. The bonds of each series, or  
12 of successive series for the same public purpose, shall mature and be payable under an  
13 annual installment plan which may be implemented by the issuance of serial maturity bonds  
14 or term bonds having mandatory sinking fund requirements, beginning not later than the  
15 second anniversary of the date of issuance of such series, and concluding on or before  
16 (a) the 30th anniversary thereof or (b) such anniversary next prior to or on the 30th  
17 anniversary of the first bond anticipation note of such series, whichever shall be earlier, or  
18 (c) the anniversary of such series representing the end of the probable useful life, or the  
19 average of the probable useful lives of the project or projects to be financed with the  
20 proceeds of such series, if such life or average lives shall be less than the maximum term  
21 authorized in (a) or (b) of this subsection.

22  
23 (4) Prior to the issue of any series of bonds authorized by this Section 2, the County  
24 Executive, or the Chief Administrative Officer if authorized by the County Executive, shall  
25 cause to be prepared a statement showing the annual debt service requirements of the  
26 County and a proposed schedule of annual maturities for the series or several series of  
27 bonds then to be issued and sold and an estimate of the annual interest charges to be  
28 incurred with respect to such bonds, based on then-prevailing interest costs. Such debt  
29 service schedule shall be so prepared with a view of achieving reasonably equal annual  
30 debt service payments for the entire outstanding bonded indebtedness of the County and,  
31 in order to achieve this result, the consecutive annual debt service payments on account of  
32 any series of such bonds need not be equal. Notwithstanding the foregoing, the debt service  
33 schedule for the entire outstanding bonded indebtedness of the County may be structured  
34 to retire debt at a rate faster than would be utilized to achieve reasonably equal annual debt  
35 service payments. As hereinafter provided, the County Executive, or the Chief  
36 Administrative Officer if authorized by the County Executive, is vested with the discretion  
37 to accept such schedule of maturities or to make such variations therein as may seem in the  
38 best interests of the County.

39  
40 (5) The County Executive, or the Chief Administrative Officer if authorized by the  
41 County Executive, may provide that all or any portion of bonds sold pursuant to the  
42 authority of this Section 2 at any one time to finance capital projects may be consolidated  
43 for sale and issued, sold and delivered as a single issue or consolidated series of bonds to  
44 be designated "Consolidated General Improvements Series, 20\_\_," without identifying by  
45 separate series each public purpose for which the bonds are issued as elsewhere provided  
46 in this Ordinance; provided that: (a) the provisions of this Ordinance requiring the  
47 identification of each group or series of bonds by the public purpose for which it is issued  
48 (e.g., "Board of Education," "Libraries," etc.) shall be fully complied with for accounting  
49 purposes, (b) bonds issued to finance water and wastewater projects shall be issued as a

1 separate consolidated issue, (c) bonds issued to finance solid waste projects, identified on  
2 Exhibit I as Self-Liquidating Bonds—Solid Waste, and bonds issued to evidence a loan  
3 from the Maryland Water Infrastructure Financing Administration may be issued as  
4 separate issues and (d) prior to the delivery of the bonds, the County Executive, or the  
5 Chief Administrative Officer if authorized by the County Executive, shall deliver a written  
6 certificate stating (i) the public purpose of each series of bonds included in the consolidated  
7 issue, (ii) the maturity schedule for each series of bonds so identified as a separate public  
8 purpose, (iii) the consolidated maturity schedule and (iv) that the maximum maturity of the  
9 bonds consolidated for issue as a single consolidated issue is not greater than the end of the  
10 probable useful life or the average of the probable useful lives, as the case may be, of the  
11 project or projects to be financed with the proceeds of such consolidated issue. A  
12 “Consolidated General Improvements Series” shall be treated as a separate series of bonds  
13 for purposes of numbering pursuant to this Ordinance. In the event that all or any portion  
14 of any bonds issued pursuant to this Section at the same time are consolidated, the title or  
15 designation of the remaining series of bonds issued at the same time may also be designated  
16 as a “consolidated” issue (e.g. “Consolidated Water and Sewer Series, 20\_\_,”  
17 “Consolidated Solid Waste Projects Series, 20\_\_”). Before any bonds are issued as part of  
18 a separate series to finance solid waste projects identified on Exhibit I as Self-Liquidating  
19 Bonds—Solid Waste, a determination must be made regarding such projects or the utility  
20 of which they are a part similar to the determination required in Paragraph (5) of the  
21 STATEMENT OF POLICY in Section 1 with regard to bonds issued for revenue projects  
22 of water or wastewater utilities. The County Executive, or the Chief Administrative Officer  
23 if authorized by the County Executive, is hereby authorized to make such changes in the  
24 forms of bonds, notice of sale, proposal and other documents in connection with any issue  
25 of bonds pursuant to this Section 2 as the County Executive or Chief Administrative  
26 Officer, as the case may be, may deem necessary or desirable in order to effect the  
27 consolidation and naming of bonds authorized hereby.

28  
29 (6) All of the (a) bonds authorized by this Section 2 hereof, (b) bond anticipation notes  
30 authorized by Section 6 hereof and (c) Refunding Bonds authorized by Section 3 hereof  
31 which are issued to refund Refunded Bonds secured as unconditional general obligations  
32 of the County shall all be deemed and shall constitute unconditional general obligations of  
33 the County, to the payment of which, both principal and interest, its full faith and credit are  
34 pledged. Subject to the following provisions, the County hereby covenants that, in each  
35 fiscal year during which any such bonds are outstanding, it will appropriate sufficient funds  
36 in each Current Expense Budget to pay the principal of such bonds and the interest thereon  
37 due in such fiscal year. The County hereby further covenants that, to the extent any such  
38 appropriation is not offset by funds from other sources or by project revenues, it will,  
39 subject to the limitation on the tax levy set out in Section 710(d) of the County Charter,  
40 fund any such appropriation by the levy of ad valorem taxes on real estate, tangible personal  
41 property and intangible personal property subject to taxation by the County, and in  
42 addition, on such other intangible property as may be subject to taxation by the County  
43 within limitations prescribed by law.

44  
45 In the case of any series of bonds issued to finance self-liquidating projects of the  
46 County or of any Refunding Bonds issued to refund Refunded Bonds for water and  
47 wastewater projects or solid waste projects, the proceeds of which were used to finance  
48 self-liquidating projects of the County, the principal of and interest on any such bonds shall  
49 be payable primarily from the net revenues and receipts from such projects, or the utilities

1 of which they form a part. If any such series of bonds shall be issued to finance such  
2 self-liquidating projects, then the County covenants to fix such rates and charges for the  
3 use of any such project, or the utility of which it forms a part, as will generate sufficient  
4 revenues to pay the annual cost of maintenance and operation thereof and to pay the  
5 maturing principal of and interest on such series of bonds when due, and the County further  
6 covenants and agrees to apply such revenues against appropriations for such maintenance,  
7 operation and debt service in each Current Expense Budget. Interest on any bonds  
8 authorized by this Section 2 and bond anticipation notes authorized by Section 6 hereof  
9 falling due during the fiscal year ending June 30, 2027, may be capitalized and paid from  
10 the proceeds of sale, and in the annual Current Expense Budgets of the County for the fiscal  
11 years ending June 30, 2028 and June 30, 2029, there shall be appropriated amounts  
12 sufficient to pay the interest accruing on any such bonds and notes then outstanding, or to  
13 be issued during such fiscal years, less the amount of interest capitalized, which, as to any  
14 such series of bonds and notes, shall not exceed twelve (12) months interest on such bonds  
15 and notes, respectively, or the amount of interest included in the cost of the capital projects  
16 to be financed with such series, whichever is smaller.

17  
18 Notwithstanding the foregoing, in accordance with Section 19-207 of the Local  
19 Government Article of the Annotated Code of Maryland (2013 Replacement Volume and  
20 2025 Supplement), in the case of any Refunding Bonds issued to refund Refunded Bonds  
21 secured as unconditional general obligations with a pledge of the full faith and credit and  
22 unlimited taxing power of the County, the County covenants that, to the extent any such  
23 appropriation to pay principal of or interest on such Refunding Bonds is not offset by funds  
24 from other sources or by project revenues, it will fund any such appropriations by the levy  
25 of ad valorem taxes on real estate, tangible personal property and intangible personal  
26 property subject to taxation by the County without limitation as to rate or amount, and in  
27 addition upon such other intangible property as may be subject to taxation by the County  
28 within limitations prescribed by law.

29  
30 (7) The rate or rates of interest payable on any series of bonds sold pursuant to this  
31 Section 2 shall not exceed the maximum interest rate, if any, specified by the County  
32 Council by public local law to be payable on obligations of the County, and, except with  
33 respect to the first interest payment, which may be longer or shorter than six months, and  
34 except as provided in Section 7 of this Ordinance in connection with the issuance and sale  
35 of Variable Rate Demand Obligations, such interest rate shall be payable in semi-annual  
36 installments, accounting from the date of issue of any such series of bonds. Interest on the  
37 bonds shall be payable by checks mailed by the paying agent therein named to the  
38 registered holder or holders of such bonds or, if such bonds shall be issued in the form of  
39 Variable Rate Demand Obligations, interest thereon may be payable by wire transfer at the  
40 discretion of the County Executive, or the Chief Administrative Officer if authorized by  
41 the County Executive. If the bonds are issued and sold in book-entry form, alternative  
42 payment arrangements may be provided at the discretion of the County Executive, or the  
43 Chief Administrative Officer if authorized by the County Executive.

44  
45 (8) The principal of the bonds authorized by this Section 2 shall be payable at the  
46 principal office of the paying agent therein named, unless the bonds are issued and sold in  
47 book-entry form, in which event alternative payment arrangements may be provided at the  
48 discretion of the County Executive, or the Chief Administrative Officer if authorized by  
49 the County Executive.

1 (9) With respect to each series of bonds sold pursuant to this Section 2, authority is  
2 hereby conferred on the County Executive, or the Chief Administrative Officer if  
3 authorized by the County Executive, to take the following actions and make the following  
4 commitments on behalf of the County:

5  
6 (a) to determine the date, time and place when proposals for the purchase of such  
7 series of bonds will be received, to publish and otherwise distribute, as prescribed in  
8 Section 5 hereof, a suitable notice of sale of such bonds and to award any series of bonds  
9 for which a legally sufficient proposal has been received to the best bidder therefor,  
10 determined as provided in such Section 5; provided, however, that the County Executive,  
11 or the Chief Administrative Officer if authorized by the County Executive, may by written  
12 statement appoint a designee who may conduct the sale on his behalf and accept bids and  
13 award bonds to the best bidder;

14  
15 (b) to appoint a bank having trust powers, or a trust company, as paying agent for  
16 any such series of bonds, notwithstanding the fact that such bank or trust company may  
17 have neither its principal office nor any branch office within the County or the State of  
18 Maryland, and to appoint a similarly qualified bank or trust company as alternate paying  
19 agent, such authority to include the power to agree with respect to the compensation of  
20 such paying agent and alternate paying agent for the services to be rendered by them and  
21 to appoint one or more of such banks or trust companies as Bond Registrars and also to  
22 confer on the manager of the syndicate purchasing such series of bonds the right to  
23 designate an alternate paying agent so to be appointed;

24  
25 (c) to fix the schedule of annual maturities of such series of bonds and the maximum  
26 rate of interest payable thereon, both within the limitations prescribed above;

27  
28 (d) to employ, as financial advisor with respect to the sale of such series of bonds,  
29 a firm or corporation that is registered as a municipal advisor pursuant to the Securities  
30 Exchange Act of 1934, as amended; to arrange, together with such financial advisor, for  
31 the preparation and distribution of an appropriate Offering Circular, Official Statement or  
32 Official Circular with respect to the sale of such series of bonds, including (without  
33 limitation) the employment of a qualified financial printer to print such Offering Circular,  
34 Official Statement or Official Circular; and to allocate in his discretion the costs of  
35 employing such financial advisor and financial printer and the other costs of preparing and  
36 distributing such Offering Circular, Official Statement or Official Circular among the  
37 projects to be financed with the proceeds of such series of bonds, as part of the costs  
38 thereof, all such costs of employing such financial advisor and financial printer and all  
39 other costs of preparing and distributing such Offering Circular, Official Statement or  
40 Official Circular to be regarded as costs of specialized services of an unusual nature and  
41 not susceptible of being obtained through competitive bidding;

42  
43 (e) after considering any recommendations of such financial advisor, to reserve to  
44 the County the option to redeem such series of bonds in whole or in part, at such times and  
45 upon payment of such premiums as such financial advisor may recommend;

46  
47 (f) to retain qualified bond counsel (such qualifications to be subject to approval by  
48 the County Attorney) to handle all legal proceedings with respect to the issue and sale of  
49 such series of bonds and to pass on the validity thereof and to employ, if bonds are not

1 issued and sold in book-entry form, or if otherwise deemed necessary by the County  
2 Executive, a qualified banknote company to print or engrave such bonds in accordance  
3 with established standards, and to allocate in his discretion the costs of retaining such  
4 counsel and employing such banknote company among the projects to be financed with the  
5 proceeds of such series of bonds, as part of the costs thereof, all such costs of retaining  
6 such counsel and employing such banknote company to be regarded as costs of specialized  
7 services of an unusual nature and not susceptible of being obtained through competitive  
8 bidding; and

9  
10 (g) to provide for the issuance of bonds in book-entry form, to provide for the  
11 manner of payment of principal of and interest on bonds issued in book-entry form and to  
12 enter into appropriate agreements regarding the custody of bonds issued in book-entry  
13 form.

14  
15 SECTION 3. *And be it further enacted*, That acting pursuant to the authority of Section  
16 10-203 of the Local Government Article of the Annotated Code of Maryland (2013  
17 Replacement Volume and 2025 Supplement), the County Charter and Section 19-207 of  
18 the Local Government Article of the Annotated Code of Maryland (2013 Replacement  
19 Volume and 2025 Supplement) (the “Refunding Act”), the issuance and sale of bonds of  
20 the County (the “Refunding Bonds”) is hereby authorized for the purpose of refunding  
21 some or all of the outstanding issues of bonds of the County listed on Exhibit II attached  
22 hereto, as follows:

23  
24 (a) Refunding Bonds are hereby authorized to be issued to refund in whole or in part  
25 the several series of Anne Arundel County Consolidated General Improvements Series,  
26 Anne Arundel County Consolidated Water and Sewer Series and Anne Arundel County  
27 Water Infrastructure Bonds identified as to designation, date and aggregate outstanding  
28 principal amount on Exhibit II attached hereto (to the extent refunded as provided herein,  
29 the “Refunded Series” or “Refunded Bonds”). The amount of any Refunding Bonds shall  
30 be reduced to take account of any principal payments made on such Refunded Series prior  
31 to such refunding. With respect to each Refunded Series, Refunding Bonds may be issued  
32 pursuant to this Ordinance in an aggregate principal amount sufficient to provide funds  
33 (i) to purchase direct obligations of, or obligations the timely payment of the principal of  
34 and interest on which is unconditionally guaranteed by, the United States of America  
35 (“Government Obligations”), the principal of and interest on which will be sufficient  
36 without reinvestment, or to provide cash sufficient, in either case, to pay in a timely manner  
37 all or any part of the principal of and redemption premium, if any, and interest on the  
38 portion of the bonds of such Refunded Series refunded hereby and, if so provided by the  
39 County Executive, or Chief Administrative Officer if authorized by the County Executive,  
40 pursuant to Section 3(b)(6) of this Ordinance, a portion of the interest on the Refunding  
41 Bonds, and (ii) to pay any and all other costs permitted to be paid from the proceeds of  
42 such bonds under the Refunding Act, including (without limitation) the costs of issuance  
43 of such Refunding Bonds and applicable underwriting fees; provided, however, that the  
44 aggregate principal amount of Refunding Bonds issued to refund one or more Refunded  
45 Series shall not exceed 120% of the principal amount of bonds of the Refunded Series so  
46 refunded. Proceeds of Refunding Bonds, including bond premium, consisting of net bond  
47 proceeds from the sale of bonds sold at a price above par, shall be applied for the purposes  
48 set forth above and as prescribed in the Refunding Act. Accordingly, bond premium, if

1 any, derived from the sale of Refunding Bonds shall be applied as described above and  
2 shall not be subject to any requirement for expenditure on capital improvements.

3  
4 (b) The Refunding Bonds shall be issued and sold in the same manner as Bonds  
5 authorized by Section 2 hereof with the following exceptions and additions:

6  
7 (1) Refunding Bonds shall be sold at private (negotiated) sale, and such procedure  
8 is hereby determined to be in the public interest. Notwithstanding the foregoing, if the  
9 County Executive, or the Chief Administrative Officer if authorized by the County  
10 Executive, subsequently determines that it is in the best interests of the County to sell any  
11 or all of the Refunding Bonds after first soliciting competitive bids at public sale, then the  
12 County Executive or the Chief Administrative Officer, as the case may be, may sell such  
13 Refunding Bonds in such manner in accordance with such procedures as deemed  
14 appropriate; provided, however, that such procedures shall be substantially similar to the  
15 procedures set forth in Section 5 hereof.

16  
17 (2) Refunding Bonds issued hereunder are hereby specifically exempted from the  
18 provisions of Sections 19-205 and 19-206 of the Local Government Article of the  
19 Annotated Code of Maryland (2013 Replacement Volume and 2025 Supplement).

20  
21 (3) Refunding Bonds authorized to be issued for the purposes specified above may  
22 be issued in series from time to time. Each such series shall identify the public purpose for  
23 which it is issued, by the printing on each bond of the words "Consolidated General  
24 Improvements Series, 20\_ Refunding Series," "Consolidated Water and Sewer Series, 20\_\_  
25 Refunding Series" or "Consolidated Solid Waste Projects Series, 20\_\_ Refunding Series,"  
26 as the case may be. The County Executive, or the Chief Administrative Officer if  
27 authorized by the County Executive, may incorporate such additional designations in the  
28 name of the series as deemed necessary or convenient to distinguish two or more series  
29 issued for the same purpose within the same calendar year.

30  
31 (4) The Refunding Bonds of each series, or of successive series for the same public  
32 purpose, shall mature and be payable under an annual installment plan ("Installment Plan")  
33 which may be implemented by the issuance of serial maturity bonds or term bonds having  
34 mandatory sinking fund requirements, beginning not later than the second anniversary of  
35 the date of issuance of such series and concluding on or before (a) the thirtieth (30th)  
36 anniversary of the Refunded Bonds to be refunded from the proceeds of such Series or  
37 (b) the final maturity date permitted for such series under Paragraph (3) of Section II of the  
38 FINDINGS OF FACT set forth in Section 1 of this Ordinance, whichever shall be earlier.  
39 In the event that bonds of more than one series of Refunded Bonds are refunded by a single  
40 series of Refunding Bonds, compliance with the maturity limits contained herein shall be  
41 established with respect to each series of Refunded Bonds in a certificate of the County  
42 Executive, or the Chief Administrative Officer if authorized by the County Executive,  
43 delivered in connection with the issuance of such Refunding Bonds.

44  
45 (5) The County Executive, or the Chief Administrative Officer if authorized by the  
46 County Executive, shall determine the portions of each series of Refunded Bonds to be  
47 refunded with the proceeds of each series of Refunding Bonds; provided, however, that  
48 such refunding will effectuate and accomplish the public purpose of realizing savings to

1 the County in the aggregate cost of debt service on either a direct comparison or a present  
2 value basis with respect to the portion of any series of Refunded Bonds being refunded.

3  
4 (6) With respect to each series of Refunding Bonds sold pursuant to this Ordinance,  
5 authority is hereby conferred on the County Executive, or the Chief Administrative Officer  
6 if authorized by the County Executive, in addition to the authority conferred by Section 2  
7 hereof, to take the following actions and make the following commitments on behalf of the  
8 County:

9  
10 (a) to sell any series of Refunding Bonds upon such terms deemed favorable  
11 under the existing market conditions to a bank, investment banking firm or other financial  
12 institution as, in his judgment, offers to purchase such series of bonds on terms deemed  
13 favorable to the County under the existing market conditions;

14  
15 (b) to execute and deliver, as a binding and enforceable obligation of the  
16 County, an underwriting or purchase agreement for any series of Refunding Bonds;

17  
18 (c) to determine whether the principal of Refunded Bonds shall be paid at  
19 maturity, at the earliest redemption date pertaining thereto, or at some later redemption  
20 date; and

21  
22 (d) to select a trust company or other banking institution as trustee, to hold the  
23 trust fund into which the proceeds of the sale of any Refunding Bonds may be deposited  
24 under the Refunding Act, to determine the terms of any such trust fund, including any  
25 provisions relating to the payment of costs or the payment of a portion of the interest on  
26 such series of Refunding Bonds therefrom, and to deliver, as a binding commitment of the  
27 County, a trust or escrow agreement pursuant to which such trust fund is established.

28  
29 SECTION 4. *And be it further enacted*, That the several series of bonds to be issued  
30 pursuant to the authority of this Ordinance shall be executed on behalf of the County by  
31 the manual or facsimile signature of the County Executive and the seal or a facsimile of  
32 the seal of the County shall be impressed or imprinted thereon, attested by the manual or  
33 facsimile signature of the County Executive, the secretary to the County Executive, the  
34 Administrative Officer to the County Council or such other officer as may be specified by  
35 ordinance of the County Council. Each such bond shall be authenticated by the manual or  
36 facsimile signature of the Chief Administrative Officer or his authorized deputy and by the  
37 manual signature of an authorized officer of the Bond Registrar. Notwithstanding the  
38 foregoing, in the event bonds are issued in book-entry form the County Executive or the  
39 Chief Administrative Officer if authorized by the County Executive, may provide that  
40 bonds issued in such form need not be authenticated by a Bond Registrar. No bonds issued  
41 hereunder shall be valid for any purpose or constitute an obligation of the County unless  
42 so authenticated.

43  
44 Each series of bonds shall be in the form set forth in Exhibit III attached hereto and  
45 incorporated herein by this reference, and bonds issued substantially in compliance with  
46 such forms, with such insertions, alterations, additions or deletions as are herein permitted,  
47 when properly executed and authenticated as described above, shall be deemed to  
48 constitute unconditional general obligations of the County, to the payment of which, in  
49 accordance with the terms thereof, its full faith and credit are pledged, subject to the

1 limitation on the taxing power set forth in Section 710(d) of the County Charter, and all  
2 the covenants and conditions contained in such bonds shall be deemed to be binding upon  
3 the County in accordance therewith.  
4

5 In case any official of the County whose signature shall appear on any such bonds shall  
6 cease to be such official prior to the delivery of such bonds, or in the case that any such  
7 official shall take office subsequent to the date of issue of any such bonds, his signature, in  
8 either event, shall nevertheless be valid for the purposes herein intended.  
9

10 The County Executive, or the Chief Administrative Officer if authorized by the County  
11 Executive, may make arrangements to make the approving legal opinion available to the  
12 holder of such bonds.  
13

14 Authority is hereby conferred on the County Executive, or the Chief Administrative  
15 Officer if authorized by the County Executive, to complete the blanks in such forms with  
16 the required information, to insert applicable paragraphs as indicated and to make such  
17 additions, deletions and substitutions in such forms, not inconsistent herewith, as may be  
18 necessary or desirable in the sale of any such series of bonds or to provide for the sale of  
19 any such series of bonds in book-entry form, including (without limitation) modifications  
20 in the form of bonds to provide for Refunding Bonds issued to refund Refunded Bonds  
21 meeting the requirements of Section 19-207 of the Local Government Article of the  
22 Annotated Code of Maryland (2013 Replacement Volume and 2025 Supplement) to be  
23 secured by a pledge of the full faith and credit and unlimited taxing power of the County,  
24 or, with respect to bonds sold in book-entry form, to provide for payment of the redemption  
25 price of such bonds without presentation thereof to the County or to the Bond Registrar.  
26 Without limiting the generality of the foregoing, the County Executive, or the Chief  
27 Administrative Officer if authorized by the County Executive, is hereby specifically  
28 authorized to make such additions, deletions and substitutions in such forms, not  
29 inconsistent herewith, as may be deemed necessary or desirable in the event that any series  
30 of bonds issued hereunder (i) is not made subject to redemption prior to their respective  
31 maturities or (ii) is issued as Variable Rate Demand Obligations in accordance with the  
32 provisions of Section 7 of this Ordinance.  
33

34 SECTION 5. *And be it further enacted*, That any bonds hereafter sold pursuant to the  
35 authority of Section 2 of this Ordinance shall first be offered at public sale to the best bidder  
36 therefor and only after the solicitation of competitive bids on a sealed basis pursuant to a  
37 notice of sale substantially in the form set forth in Exhibit IV attached hereto and  
38 incorporated herein by this reference, with such insertions, alterations, additions or  
39 deletions as are permitted by this Ordinance.  
40

41 The best bidder for such bonds shall be determined in accordance with a formula and  
42 subject to such bid constraints as shall be determined by the County Executive, or the Chief  
43 Administrative Officer if authorized by the County Executive, upon the recommendation  
44 of the financial advisor selected pursuant to Section 2 hereof, to be appropriate for the  
45 solicitation or determination of the best bid for the bonds. The notice or summary thereof  
46 shall be published at least once preceding the date of sale in a newspaper published and of  
47 general circulation in the County. The first publication of any such notice or summary shall  
48 be not less than 10 days prior to the date of sale. At the discretion of the County Executive,  
49 or the Chief Administrative Officer if authorized by the County Executive, such notice or

1 a summary thereof may also be inserted one or more times in financial journals published  
2 elsewhere in the United States. If more than one series or issue of bonds are offered  
3 together, they may be sold as a unit or by receipt of separate bids. Following any such sale,  
4 the County Executive, or the Controller of the County (the "Controller") if authorized by  
5 the County Executive, shall report the results thereof in writing at the next meeting of the  
6 County Council.

7  
8 The County may in such notice of sale reserve unto itself the right to reject any or all  
9 of the bids made pursuant to such notice and if, pursuant to the power so reserved, all of  
10 such bids are so rejected at the public sale of any of the bonds, then the County may, within  
11 30 days, but not thereafter, offer to sell or sell all or any part of such bonds by private sale  
12 for a price not less than the best bid received by the County from an acceptable bidder at  
13 the public sale thereof, and if such bonds are not sold either at such public sale or at private  
14 sale within such 30 day period, then they may not be sold in any manner except upon a  
15 subsequent public sale duly advertised in the manner herein specified.

16  
17 The County may in such notice of sale reserve the right to adjust the principal amount  
18 of each maturity of bonds of any series after publication of the notice of sale as provided  
19 herein, provided that any such adjustment shall be made in accordance with the procedures  
20 set forth in the notice of sale.

21  
22 The form of such notice of sale shall be substantially as set forth in Exhibit IV, with  
23 the insertions therein indicated, and subject to such insertions, alterations, additions or  
24 deletions as the County Executive, or the Chief Administrative Officer if authorized by the  
25 County Executive, may deem advisable due to financial or market conditions prevailing at  
26 the time or, in the event that bonds are issued as Variable Rate Demand Obligations in  
27 accordance with Section 7 of this Ordinance or constitute Refunding Bonds meeting the  
28 requirements of Section 19-207 of the Local Government Article of the Annotated Code  
29 of Maryland (2013 Replacement Volume and 2025 Supplement), due to the particular  
30 characteristics of such bonds or the security therefor. Without limiting the generality of the  
31 foregoing, the County Executive, or the Chief Administrative Officer if authorized by the  
32 County Executive, is hereby specifically authorized, upon recommendation of the financial  
33 advisor and bond counsel, to make such insertions, alterations, additions or deletions as  
34 may be deemed necessary or desirable (a) in the event that the bonds of any series issued  
35 hereunder (i) are not made subject to redemption prior to their respective maturities, (ii) are  
36 issued as Variable Rate Demand Obligations in accordance with the provisions of Section  
37 7 of this Ordinance or (iii) constitute Refunding Bonds meeting the requirements of Section  
38 19-207 of the Local Government Article of the Annotated Code of Maryland (2013  
39 Replacement Volume and 2025 Supplement), (b) to provide for receipt of bids submitted  
40 electronically or (c) to reflect use of a book-entry only system.

41  
42 SECTION 6. *And be it further enacted*, That in order to avoid the issuance of a greater  
43 amount of bonds for the capital projects listed in Exhibit I than is needed therefor, and in  
44 order to permit the construction of such projects to proceed prior to the issuance of such  
45 bonds and at the same time afford the County maximum flexibility in selecting the most  
46 advantageous times for such issuance, the County may provide needed capital funds by the  
47 issue and sale of its bond anticipation notes pursuant to the authority of Section 19-212 of  
48 the Local Government Article of the Annotated Code of Maryland (2013 Replacement

1 Volume and 2025 Supplement) (the “Bond Anticipation Note Act”). Such notes shall bear  
2 the same series identification as the bonds authorized in Section 2 hereof.

3  
4 (1) The maximum principal amount of such notes issued pursuant to this Section which  
5 may be outstanding at any time shall be Nine Hundred Million Dollars (\$900,000,000)  
6 unless and until otherwise provided by the County Council by ordinance. The notes may  
7 be paid at or prior to maturity from the proceeds of the issuance and sale of the bonds in  
8 anticipation of which such notes were issued or from the proceeds of refunding bond  
9 anticipation notes. Except as otherwise provided herein, in the event of such an advance  
10 refunding, the proceeds of such refunding bonds or notes shall be held in escrow, to the  
11 extent and in the amount necessary to refund the outstanding series of notes, for the benefit  
12 of the holders of the outstanding series of notes. Such refunding bond anticipation notes, if  
13 issued, will constitute a reissuance of the bond anticipation notes authorized by this  
14 Ordinance and shall not constitute additional indebtedness under such authorization.

15  
16 (2) The notes shall be issued in registered form without coupons or in bearer form  
17 without coupons, in the denomination of \$5,000 each or any integral multiple thereof, as  
18 may be determined by the County Executive, or the Chief Administrative Officer if  
19 authorized by the County Executive. Each such note shall be dated (i) as of the first or  
20 fifteenth day of the month in which it is sold, and accrued interest shall be adjusted to such  
21 date or (ii) as of the date of the initial sale and delivery of such note, all as may be  
22 determined by the County Executive, or the Chief Administrative Officer if authorized by  
23 the County Executive. All of the notes authorized hereby shall mature and be payable on  
24 such date as may be determined by the County Executive, or the Chief Administrative  
25 Officer if authorized by the County Executive, within the limitations of this Ordinance and  
26 the Bond Anticipation Note Act. The County Executive, or the Chief Administrative  
27 Officer if authorized by the County Executive, may also provide for (a) the extension of  
28 maturity of such notes, at the option of the County exercised by the County Executive or  
29 the Chief Administrative Officer if authorized by the County Executive, for an additional  
30 period not in excess of six months, upon such terms and conditions as the County  
31 Executive, or the Chief Administrative Officer if authorized by the County Executive, shall  
32 prescribe and (b) the redemption of such notes prior to their maturity, with or without  
33 premium or penalty.

34  
35 (3) All or any part of such notes may be issued in series as funds are required. Authority  
36 is hereby conferred on the County Executive, or the Chief Administrative Officer if  
37 authorized by the County Executive, to determine whether such notes will be issued in such  
38 series and, if so, when each such series of notes will be delivered to the purchaser thereof.

39  
40 (4) The County Executive, or the Chief Administrative Officer if authorized by the  
41 County Executive, shall provide for the establishment and maintenance of books for the  
42 registration and transfer of registered notes, which books may be maintained by a Note  
43 Registrar appointed by the County Executive, or the Chief Administrative Officer if  
44 authorized by the County Executive.

45  
46 (5) Notes to be issued pursuant to the authority of this Ordinance shall be executed on  
47 behalf of the County by the manual or facsimile signature of the County Executive and the  
48 seal of the County or a facsimile thereof shall be impressed or imprinted thereon, attested  
49 by the manual or facsimile signature of the County Executive, the secretary to the County

1 Executive, the Administrative Officer to the County Council or such other officer as may  
2 be specified by ordinance of the County Council. Each note shall be authenticated by the  
3 manual or facsimile signature of the Chief Administrative Officer or his authorized deputy.  
4 In the event that registered notes are issued, the County Executive, or the Chief  
5 Administrative Officer if authorized by the County Executive, may provide for  
6 authentication of such registered notes by a Note Registrar in such form as shall be deemed  
7 appropriate. In the event that Program Notes (hereinafter defined) are issued, or in the event  
8 that the notes are issued as Variable Rate Demand Obligations, the County Executive, or  
9 the Chief Administrative Officer if authorized by the County Executive, may provide for  
10 authentication of such Program Notes or Variable Rate Demand Obligations by such agents  
11 or entities and in such form as shall be deemed appropriate.  
12

13 (6) The notes shall bear interest at such rate or rates as shall be established by the  
14 County Executive, or the Chief Administrative Officer if authorized by the County  
15 Executive, which rate or rates may vary according to an established index. Interest on the  
16 notes shall be payable on such dates and in such manner as shall be established by the  
17 County Executive, or the Chief Administrative Officer if authorized by the County  
18 Executive.  
19

20 (7) Unless otherwise provided by an ordinance of the County Council prior to the  
21 issuance of any of such notes, authority is hereby conferred on the County Executive, or  
22 the Chief Administrative Officer if authorized by the County Executive, to sell such notes  
23 on the most favorable terms available from time to time, without solicitation of competitive  
24 bids, at private (negotiated) sale, and such method of sale is hereby found and determined  
25 to be in the best interests of the County. If the County Executive, or the Chief  
26 Administrative Officer if authorized by the County Executive, shall determine that the best  
27 interests of the County will be served by the sale of all or part of the notes at a public sale  
28 with the solicitation of competitive bids, the County Executive or the Chief Administrative  
29 Officer, as the case may be, is hereby authorized to sell such notes in such manner. Except  
30 as hereinafter provided with respect to Commercial Paper Notes (hereinafter defined),  
31 (a) such notes shall be sold at a price equal to the par value thereof plus accrued interest to  
32 the date of delivery, or (b) upon written recommendation of the financial advisor selected  
33 pursuant to subsection (9) of Section 2 that a discount bid would be expected to provide a  
34 more favorable interest rate to the County by facilitating the underwriting of the County's  
35 notes in then-current market conditions, the County Executive, or the Chief Administrative  
36 Officer if authorized by the County Executive, may authorize such notes to be sold at a  
37 price not less than 99% of par plus accrued interest to date of delivery. None of such notes  
38 shall bear interest at a rate in excess of the maximum interest rate, if any, specified by the  
39 County Council by Public Local Law to be payable on obligations of the County.  
40

41 In the event that such notes are sold at private (negotiated) sale, the County Executive,  
42 or the Chief Administrative Officer if authorized by the County Executive, is hereby  
43 authorized to negotiate with any bank, banker or other financial institution for a loan  
44 commitment and to deliver to such bank, banker or other financial institution such notes at  
45 one time or from time to time, as funds are required, pursuant to the terms of such  
46 commitment, and to execute and deliver any and all documents necessary or deemed  
47 appropriate by the County Executive or the Chief Administrative Officer, as the case may  
48 be, to consummate the sale of such notes at private (negotiated) sale and to accomplish any  
49 and all actions necessary or deemed appropriate by the County Executive or the Chief

1 Administrative Officer, as the case may be, to issue and deliver such notes to the purchaser  
2 thereof in accordance with the provisions of this Ordinance and any such commitment.

3  
4 In the event that such notes are sold at public sale, the County Executive, or the Chief  
5 Administrative Officer if authorized by the County Executive, is hereby authorized (i) to  
6 determine the timing, terms and conditions thereof, (ii) to publish an appropriate notice of  
7 sale, such notice of sale to be in the general form of the form of the notice of sale included  
8 herein in Section 5 for the sale of bonds authorized by Section 2 hereof, with such  
9 alterations, deletions, substitutions and additions as the County Executive, or the Chief  
10 Administrative Officer if authorized by the County Executive, shall deem necessary or  
11 appropriate to provide for proper notice of the sale of notes, (iii) to determine the date, time  
12 and place when proposals will be accepted for such notes, such proposals to specify the  
13 interest rate or rates to be paid on such notes, the price to be paid for such notes and such  
14 other matters as the County Executive or the Chief Administrative Officer, as the case may  
15 be, may deem necessary or desirable in order to sell and deliver such notes and to award  
16 such notes at public sale to the successful bidder for such notes, and (iv) to execute and  
17 deliver any and all documents necessary or deemed appropriate by the County Executive  
18 or the Chief Administrative Officer, as the case may be, to consummate the sale of such  
19 notes at public sale and to accomplish any and all actions necessary or deemed appropriate  
20 by the County Executive or the Chief Administrative Officer, as the case may be, to issue  
21 and deliver such notes to such underwriters or purchasers in accordance with the provisions  
22 of this Ordinance and any contract of sale with the successful bidder for the notes.

23  
24 Following each such sale, or the negotiation of each such commitment, including the  
25 execution of any agreements in connection with the issuance of Program Notes or Variable  
26 Rate Demand Obligations, the County Executive, or the Controller if authorized by the  
27 County Executive, shall report the same at the next meeting of the County Council and  
28 shall accompany such report with the data relied upon to satisfactorily obtain terms  
29 favorable to the County in the then-prevailing market for comparable obligations.

30  
31 (8) The authority conferred on the County Executive, or the Chief Administrative  
32 Officer if authorized by the County Executive, in paragraph (9) of Section 2 of this  
33 Ordinance in connection with the issuance of bonds hereunder, with respect to the  
34 appointment of paying agents and a registrar, the employment of a financial advisor, a  
35 financial printer and a securities printer, retaining bond counsel and the preparation and  
36 distribution of an appropriate Offering Circular, Official Statement or Official Circular,  
37 may also be exercised with respect to the issuance and sale of bond anticipation notes  
38 hereunder.

39  
40 (9) With respect to any notes issued, the County hereby covenants and agrees with the  
41 holder or holders thereof to issue, upon its full faith and credit, the bonds in anticipation of  
42 the sale of which such notes are issued when, and as soon as, the reason for deferring the  
43 issuance thereof no longer exists and to pay the principal of and interest on (to the extent  
44 such interest has not been capitalized, or otherwise paid, by appropriations from current  
45 revenues as hereinbefore authorized) such notes from the proceeds of such bonds. This  
46 covenant shall be binding upon the County notwithstanding any limitation set forth in this  
47 Ordinance, including (without limitation) any limitation with respect to the interest rate or  
48 rates that the bonds may bear. If the County shall be unable, for reasons beyond its control,  
49 to issue and sell its bonds as described above, or if the proceeds from the sale of such bonds

1 shall be insufficient to pay the principal of and interest on any notes issued, then the  
2 revenues from taxes and other sources intended for application to debt service on such  
3 bonds shall be applied to the payment of the interest on and principal of the notes. The  
4 foregoing provisions shall not be construed so as to prohibit the County from paying the  
5 principal or redemption price of and interest on any note issued hereunder from the  
6 proceeds of the sale of any other note issued hereunder, or from any other funds legally  
7 available for that purpose.

8  
9 If the County shall be unable, for reasons beyond its control, to issue and sell its bonds,  
10 or if the proceeds from the sale of such bonds shall be insufficient to pay the principal of  
11 or interest on any notes issued, then the County hereby covenants that, in each fiscal year  
12 during which any such bond anticipation notes are outstanding, it will appropriate sufficient  
13 funds in each Current Expense Budget to pay the principal of such bond anticipation notes  
14 and the interest thereon due in such fiscal year. The County hereby further covenants that,  
15 to the extent any such appropriation is not offset by funds from other sources or by project  
16 revenues, it will, subject to the limitation on the tax levy set out in Section 710(d) of the  
17 County Charter, fund any such appropriation by the levy of ad valorem taxes on real estate,  
18 tangible personal property and intangible personal property subject to taxation by the  
19 County, and in addition, on such other intangible property as may be subject to taxation by  
20 the County within limitations prescribed by law. In such event, in the case of any series of  
21 bond anticipation notes issued to finance self-liquidating projects of the County, the  
22 principal of and interest on any such notes shall be payable primarily from the net revenues  
23 and receipts from such projects, or the utilities of which they form a part. If any such series  
24 of bond anticipation notes shall be issued to finance such self-liquidating projects and the  
25 County shall be unable for reasons beyond its control to issue and sell the bonds in  
26 anticipation of the sale of which such notes are issued, or if the proceeds from the sale of  
27 such bonds shall be insufficient to pay the principal of and interest on such notes, then the  
28 County covenants to fix such rates and charges for the use of any such project, or the utility  
29 of which it forms a part, as will generate sufficient revenues to pay the annual cost of  
30 maintenance and operation thereof and to pay the maturing principal of and interest on such  
31 series of bond anticipation notes when due, and the County further covenants and agrees  
32 to apply such revenues against appropriations for such maintenance, operation and debt  
33 service in each Current Expense Budget. The County may apply to the payment of the  
34 principal of and interest on the aforementioned notes any funds granted or otherwise  
35 obtained and legally available for the payment of the principal of and interest on the notes;  
36 and to the extent that any such funds received or receivable in any fiscal year are applied  
37 to such purposes, the taxes, rates and charges required to be levied or assessed pursuant to  
38 this paragraph shall be reduced proportionately.

39  
40 (10) In the event that any notes (the "Outstanding Notes") issued hereunder are  
41 outstanding on the date that the bonds in anticipation of which such notes are issued are  
42 delivered in exchange for the purchase price thereof (the "Delivery Date"), the Controller  
43 shall deposit with the paying agent for the notes, or a trustee or escrow agent, on the  
44 Delivery Date (i) cash in an amount equal to the principal of the Outstanding Notes or  
45 (ii) direct obligations of, or obligations the payment of which is unconditionally guaranteed  
46 by, the United States of America, the principal of and interest on which will be sufficient  
47 without reinvestment to pay in a timely manner the principal of the Outstanding Notes  
48 when due. Such paying agent or trustee or escrow agent is hereby irrevocably directed to  
49 apply such cash or the proceeds of such obligations to the payment of the principal of the

1 Outstanding Notes when due. The County may provide such cash or obligations from the  
2 proceeds of the sale of such bonds or from any other funds legally available for such  
3 purpose. On the Delivery Date, the Controller shall also deposit with the paying agent for  
4 the Outstanding Notes, or a trustee or escrow agent (i) cash in an amount sufficient to pay  
5 the interest on the Outstanding Notes when due or (ii) direct obligations of, or obligations  
6 the payment of which is unconditionally guaranteed by, the United States of America, the  
7 principal of and interest on which will be sufficient without reinvestment to pay in a timely  
8 manner interest on the Outstanding Notes when due. The County may provide such cash  
9 or obligations from the proceeds of the sale of bonds available for that purpose or from any  
10 other funds legally available for such purpose. Notwithstanding the foregoing, if the  
11 Delivery Date and the date on which the Outstanding Notes mature are in different fiscal  
12 years, and money for the payment of the interest on the Outstanding Notes has not been  
13 finally appropriated in the fiscal year in which the bonds are delivered, and if the Delivery  
14 Date is after the date on which the budget for the succeeding fiscal year has been submitted  
15 to the County Council and provision for the payment of the interest on such Outstanding  
16 Notes has been made in such budget, in lieu of the deposit of such cash or obligations for  
17 the payment of interest on the Outstanding Notes, the County Executive, the Controller and  
18 the Chief Administrative Officer may deliver a certificate on the Delivery Date of the bonds  
19 stating that funds sufficient to pay the interest on the Outstanding Notes have been included  
20 in the budget for the next succeeding fiscal year (it being provided by the Bond  
21 Anticipation Note Act that the notes shall be payable from the first proceeds of the sale of  
22 the bonds, or from the tax or other revenue which the County shall have previously  
23 determined to apply to the payment of the bonds and the interest thereon). Upon the deposit  
24 with the paying agent for the Outstanding Notes, or a trustee or escrow agent, of cash or  
25 obligations sufficient to provide for the payment of the principal of and interest on such  
26 notes when due, as described above, such notes shall be deemed to be paid and no longer  
27 outstanding hereunder.

28  
29 (11) Pursuant to the Bond Anticipation Note Act, the County is hereby authorized to  
30 issue the aforementioned bond anticipation notes as notes in the nature of commercial paper  
31 and to establish a commercial paper program. Accordingly, the County is hereby  
32 authorized to issue two or more separate and distinct series of its bond anticipation notes,  
33 which may include (1) a series of its bond anticipation notes in the nature of commercial  
34 paper (the "Commercial Paper Notes") and (2) a series of its bond anticipation notes in  
35 connection with a liquidity facility, such as a revolving loan agreement, or a credit facility,  
36 such as a letter of credit and related agreements (collectively, the "Revolving Loan Notes")  
37 (the Commercial Paper Notes and the Revolving Loan Notes being collectively referred to  
38 herein as the "Program Notes"). The words "bond anticipation notes," as used in this  
39 Ordinance, include Program Notes, and it is intended that the provisions of this Ordinance  
40 applying to bond anticipation notes shall include Program Notes unless the context clearly  
41 requires a contrary meaning.

42  
43 For the purposes of this Ordinance, the term "principal amount," when used with  
44 respect to the Program Notes, shall mean (i) in the case of Commercial Paper Notes, the  
45 face amount of any such Commercial Paper Note, less any original issue discount on such  
46 Commercial Paper Note, and (ii) in the case of Revolving Loan Notes, the principal amount  
47 actually advanced under the applicable liquidity facility or credit facility that is evidenced  
48 by such Revolving Loan Note. Accordingly, it is contemplated by this Ordinance that the  
49 aggregate face amount of the Program Notes that may be outstanding from time to time

1 hereunder, together with other bond anticipation notes issued hereunder and outstanding  
2 from time to time, may exceed the aggregate principal amount of bond anticipation notes  
3 authorized to be outstanding hereunder at any one time.

4  
5 It is recognized that the procedures necessary or desirable to implement a commercial  
6 paper program within the framework of existing commercial practices in the commercial  
7 paper market may require the County to prescribe procedures to facilitate the prompt  
8 determination and approval of certain matters in connection with the authorization,  
9 issuance, execution, sale, delivery and payment of and for Program Notes. Accordingly,  
10 the County Executive, by or pursuant to executive order or other appropriate action or  
11 proceedings, is hereby authorized (1) to establish such procedures, including (without  
12 limitation) procedures for (a) the determination of the dates and maturities of any Program  
13 Notes, or the method by which the same shall be determined, (b) the determination of the  
14 interest rate to be borne by any Program Notes, which may be separately stated by rate or  
15 amount or which may be in an amount equal to the discount thereon, or the method by  
16 which the same shall be determined, and (c) the determination of the price or prices at  
17 which Commercial Paper Notes may be sold, which may be at, above or below the face  
18 value thereof, or the method by which the same shall be determined; and (2) to determine  
19 any and all other matters relating to the terms, specifications and form of such Program  
20 Notes, including (without limitation) any modification required in the forms of bond  
21 anticipation note set forth herein to accommodate the needs of the commercial paper  
22 program. Any such procedures may include provisions for telephonic approval and  
23 subsequent electronic mail or written confirmation of one or more of such matters by the  
24 Chief Administrative Officer, the Controller or such other officers or employees of the  
25 County as the County Executive shall designate within guidelines or parameters prescribed  
26 by the County Executive. The establishment of such procedures and all such determinations  
27 and actions shall be deemed to be of an administrative nature.

28  
29 In connection with the establishment of a commercial paper program, the County  
30 Executive is hereby authorized, by or pursuant to executive order or other appropriate  
31 action or proceedings (i) to approve the form of any indenture necessary or appropriate in  
32 connection with the issuance of any Program Notes (the "Indenture") and to appoint a  
33 trustee (the "Trustee") thereunder, (ii) to approve the form of any dealer agreement relating  
34 to any Commercial Paper Notes (the "Dealer Agreement") and to select a dealer to act  
35 thereunder, (iii) to approve the form of a liquidity facility, such as a revolving loan  
36 agreement, or a credit facility, such as a letter of credit and related agreements (each a  
37 "Liquidity Facility") and to select one or more financial institutions to provide loans or  
38 otherwise to act thereunder, and (iv) to approve the form of any issuing and paying agency  
39 agreement (the "Issuing and Paying Agency Agreement") and to appoint an issuing and  
40 paying agent of the County for the purpose of completing, authenticating and delivering  
41 the Program Notes from time to time.

42  
43 The County Executive is hereby authorized, pursuant to executive order or other  
44 appropriate action or proceedings, to execute and deliver on behalf of the County the  
45 Indenture, the Issuing and Paying Agency Agreement, one or more Liquidity Facilities, the  
46 Dealer Agreement, and all and any other documents that may be deemed necessary or  
47 appropriate to implement the commercial paper program contemplated by this Ordinance  
48 and, in each case, to cause the seal of the County to be impressed thereon, attested by the  
49 County Executive, the secretary to the County Executive, the Administrative Officer to the

1 County Council or such other officer as may be specified by ordinance of the County  
2 Council.

3  
4 (12) All of such notes shall be in such form as the County Executive, or the Chief  
5 Administrative Officer if authorized by the County Executive, shall deem appropriate and  
6 shall be binding on the County when and as such notes are issued and sold hereunder.

7  
8 SECTION 7. *And be it further enacted*, That it is hereby found and determined as  
9 follows: (i) general economic conditions are extremely unsettled and require sensitive and  
10 careful debt management in order to reduce to the extent practicable the cost of borrowing  
11 to the County and it is in the best interests of the County to be able to implement a flexible  
12 approach to borrowing (that is, one which provides the ability to utilize variable rate  
13 demand obligations, commercial paper and short-term municipal obligations referred to  
14 herein collectively as “Variable Rate Demand Obligations”); (ii) there is an expanding  
15 market for Variable Rate Demand Obligations, which have varying and flexible maturities  
16 or redemption features and tender or purchase dates and bear interest at variable rates  
17 established by a remarketing agent on the basis of current market conditions, or  
18 combinations of such maturities or redemption dates, tender or purchase dates and rates  
19 and to access this market, the County must establish procedures consistent with market  
20 practices for Variable Rate Demand Obligations; and (iii) existing practices in the market  
21 for Variable Rate Demand Obligations and existing requirements of nationally recognized  
22 rating agencies require that there be available to the issuer of Variable Rate Demand  
23 Obligations a supporting liquidity arrangement, such as a letter of credit, line of credit or  
24 revolving loan agreement, pursuant to which an alternate source of borrowing will be  
25 available during any period in which such obligations cannot be remarketed.

26  
27 The County Executive, or the Chief Administrative Officer if authorized by the County  
28 Executive, may determine that bond anticipation notes authorized by Section 6 hereof or  
29 bonds authorized by Section 2 hereof shall be issued as short-term or demand obligations  
30 or commercial paper, defined above as Variable Rate Demand Obligations, including  
31 obligations that are required to be purchased or redeemed prior to stated maturity dates,  
32 and bear interest at variable rates established from time to time by a remarketing agent on  
33 the basis of current market conditions. The County Executive, or the Chief Administrative  
34 Officer if authorized by the County Executive, is hereby authorized to establish procedures  
35 for the determination of the interest rates, the interest payment dates and any mandatory  
36 redemption, tender or purchase dates of bonds or notes described in this Section 7 in order  
37 to implement the financing authorized hereby. If any bonds or notes issued in accordance  
38 with this Section 7 provide for the mandatory redemption, tender or purchase thereof prior  
39 to stated maturity dates, the form of bond or note (as the case may be) may provide, to the  
40 extent permitted by law and deemed advisable by the County Executive, or the Chief  
41 Administrative Officer if authorized by the County Executive, that the full faith and credit  
42 and, subject to the limitations set forth in Section 710(d) of the County Charter, taxing  
43 power of the County are pledged to the payment of the purchase or redemption price on  
44 the due dates for such payments.

45  
46 In connection with the issuance of such obligations, the County Executive is hereby  
47 authorized, by executive order or other appropriate action or proceeding (i) to approve the  
48 form of any indenture necessary or appropriate in connection with the issuance of such  
49 obligations (the “Demand Indenture”) and to appoint a trustee thereunder, (ii) to approve

1 the form of a remarketing agreement relating to such obligations (the “Demand  
2 Remarketing Agreement”) and to select a remarketing agent to act thereunder, (iii) to  
3 approve the form of a credit or liquidity facility, such as a letter of credit, line of credit,  
4 revolving loan agreement or other similar agreement (a “Demand Liquidity Facility”) and  
5 to enter into a reimbursement agreement or other similar agreement (a “Demand Liquidity  
6 Facility Agreement”) with one or more financial institutions in connection therewith and  
7 (iv) to approve the form of a registrar and paying agency agreement (the “Demand  
8 Registrar and Paying Agency Agreement”) and to appoint a registrar and paying agent for  
9 the purpose of completing, authenticating and delivering such obligations from time to  
10 time.

11  
12 The County Executive is hereby authorized pursuant to executive order or other  
13 appropriate action or proceeding, to execute and deliver on behalf of the County a Demand  
14 Indenture, a Demand Remarketing Agreement, one or more Demand Liquidity Facility  
15 Agreements and a Demand Registrar and Paying Agency Agreement and any and all other  
16 documents that may be deemed necessary or appropriate in connection with the issuance  
17 of obligations authorized by this Section 7, and, in each case, to cause the seal of the County  
18 to be impressed thereon, attested by the County Executive, the secretary to the County  
19 Executive, the Administrative Officer to the County Council or such other officers as may  
20 be specified by ordinance of the County Council.

21  
22 SECTION 8. *And be it further enacted*, That the provisions hereinafter set forth in  
23 Sections 8(1), (2), (3), (4) and (5) shall be applicable with respect to bonds (including  
24 Refunding Bonds) or bond anticipation notes issued and sold hereunder on the basis that  
25 the interest on such bonds or notes will be excludable from gross income for federal income  
26 tax purposes and the provisions hereinafter set forth in Section 8(7) shall be applicable with  
27 respect to any bonds or bond anticipation notes issued and sold hereunder on the basis that  
28 such bonds or notes are allowed a tax credit, that the County is entitled to a subsidy from  
29 the United States of America or any agency or instrumentality thereof with respect to such  
30 bonds or notes or the interest payable thereon, or that any such bond or note or the interest  
31 thereon is entitled to any other available benefits under the Internal Revenue Code of 1986,  
32 as amended (“the Code”) (any such bonds or notes being referred to herein as “Tax  
33 Advantaged Obligations”).

34  
35 (1) The County Executive, the Chief Administrative Officer or the Controller (the  
36 “Section 148 Certifying Official”) shall be the officer of the County responsible for the  
37 issuance of any bonds or bond anticipation notes hereunder within the meaning of the  
38 Arbitrage Regulations (defined herein). The Section 148 Certifying Official shall also be  
39 the officer of the County responsible for the execution and delivery (on the date of each  
40 issuance of the bonds or bond anticipation notes) of a certificate of the County (the “Section  
41 148 Certificate”) which complies with the requirements of Section 148 of the Code  
42 (“Section 148”), and the applicable regulations thereunder (the “Arbitrage Regulations”),  
43 and the Section 148 Certifying Official is hereby directed to execute the Section 148  
44 Certificate and to deliver the same to bond counsel on the date of the issuance of the bonds  
45 or bond anticipation notes.

46  
47 (2) The County shall set forth in the Section 148 Certificate its reasonable expectations  
48 as to relevant facts, estimates and circumstances relating to the use of the proceeds of the  
49 bonds or bond anticipation notes, or of any money, securities or other obligations to the

1 credit of any account of the County which may be deemed to be proceeds of the bonds or  
2 bond anticipation notes pursuant to Section 148 or the Arbitrage Regulations (collectively,  
3 “Bond Proceeds”). The County covenants that the facts, estimates and circumstances set  
4 forth in the Section 148 Certificate will be based on the County’s reasonable expectations  
5 on the date of issuance of the bonds or bond anticipation notes and will be, to the best of  
6 the certifying officials’ knowledge, true and correct as of that date.

7  
8 (3) The County covenants and agrees with each of the holders of any of the bonds or  
9 bond anticipation notes that it will not make, or (to the extent that it exercises control or  
10 direction) permit to be made, any use of the Bond Proceeds which would cause the bonds  
11 or bond anticipation notes to be “arbitrage bonds” within the meaning of Section 148 and  
12 the Arbitrage Regulations. The County further covenants that it will comply with Section  
13 148 and the Arbitrage Regulations which are applicable to the bonds or bond anticipation  
14 notes on the date of issuance of the bonds or bond anticipation notes and which may  
15 subsequently lawfully be made applicable to the bonds or bond anticipation notes.

16  
17 (4) The County further covenants that it shall make such use of the proceeds of the  
18 bonds or bond anticipation notes, regulate the investment of the proceeds thereof, and take  
19 such other and further actions as may be required to maintain the excludability from gross  
20 income for federal income tax purposes of interest on the bonds or bond anticipation notes.  
21 All officers, employees and agents of the County are hereby authorized and directed to take  
22 such actions, and to provide such certifications of facts and estimates regarding the amount  
23 and use of the proceeds of the bonds or bond anticipation notes, as may be necessary or  
24 appropriate from time to time to comply with, or to evidence the County’s compliance  
25 with, the covenants set forth in this Section.

26  
27 (5) The County Executive, or the Chief Administrative Officer if authorized by the  
28 County Executive, on behalf of the County, may make such covenants or agreements in  
29 connection with the issuance of bonds or bond anticipation notes issued hereunder as shall  
30 be deemed advisable in order to assure the registered owners of such bonds or notes that  
31 interest thereon shall be and remain excludable from gross income for federal income tax  
32 purposes, and such covenants or agreements shall be binding on the County so long as the  
33 observance by the County of any such covenants or agreements is necessary in connection  
34 with the maintenance of the exclusion of the interest on such bonds or notes from gross  
35 income for federal income tax purposes. The foregoing covenants and agreements may  
36 include such covenants or agreements on behalf of the County regarding compliance with  
37 the provisions of the Code as the County Executive, or the Chief Administrative Officer if  
38 authorized by the County Executive, shall deem advisable in order to assure the registered  
39 owners of such bonds or notes that the interest thereon shall be and remain excludable from  
40 gross income for federal income tax purposes, including (without limitation) covenants or  
41 agreements relating to the investment of the proceeds of such bonds or notes, the rebate of  
42 certain earnings resulting from such investment to the United States of America (or the  
43 payment of penalties in lieu of rebate) to the United States, limitations on the times within  
44 which, and the purposes for which, such proceeds may be expended, or the use of specified  
45 procedures for accounting for and segregating such proceeds.

46  
47 (6) Notwithstanding anything in this Ordinance to the contrary, bonds or bond  
48 anticipation notes issued and sold hereunder may be issued and sold on the basis that the

1 interest on such bonds or notes will not be excludable from gross income for federal income  
2 tax purposes.

3  
4 (7) With respect to Tax Advantaged Obligations, the County Executive, or the Chief  
5 Administrative Officer if authorized by the County Executive, is hereby authorized to make  
6 such covenants or agreements in connection with the issuance thereof as shall be deemed  
7 advisable in order to assure (i) the holders of any such Tax Advantaged Obligations that  
8 such Tax Advantaged Obligations will be entitled to federal tax benefits of such Tax  
9 Advantaged Obligations, and (ii) that the County is entitled to any subsidy available for  
10 any such Tax Advantaged Obligations. Such covenants or agreements shall be binding on  
11 the County so long as the observance by the County of any such covenants or agreements  
12 is necessary in connection with the entitlement of such Tax Advantaged Obligations to  
13 applicable federal tax benefits. The foregoing covenants and agreements may include  
14 (without limitation) covenants or agreements on behalf of the County relating to the  
15 investment of proceeds of such Tax Advantaged Obligations, the rebate of certain earnings  
16 resulting from such investment to the United States of America (or the payment of penalties  
17 in lieu of such rebate), limitations on the times within which, and the purposes for which,  
18 such proceeds may be expended or the utilization of specified procedures for accounting  
19 for and segregating such proceeds. Any covenant or agreement made by the County  
20 Executive, or the Chief Administrative Officer if authorized by the County Executive,  
21 pursuant to this paragraph may be authorized by an order or certificate of the County  
22 Executive, or the Chief Administrative Officer if authorized by the County Executive, and  
23 such covenant or agreement shall be binding on the County.

24  
25 In furtherance of the foregoing, in order to qualify for the benefits inuring with respect  
26 to any Tax Advantaged Obligation, the County Executive, or the Chief Administrative  
27 Officer if authorized by the County Executive, shall be authorized to make any elections  
28 or designations permitted or required under the Code to apply for an allocation from the  
29 State of Maryland or the federal government in the case of bonds or notes subject to any  
30 volume limitation and to apply for any tax credit, to take such actions as shall be necessary  
31 to permit any tax credit to be stripped and sold separately from the ownership interest in  
32 any Tax Advantaged Obligations and to claim any cash subsidy with respect to any Tax  
33 Advantaged Obligation.

34  
35 For purposes of establishing compliance with Sections 148 and 150 of the Code  
36 regarding the expenditure of proceeds of bonds or bond anticipation note, the proceeds of  
37 County debt issuances may be allocated to reimbursement of County funds advanced on  
38 an interim basis for expenditures authorized to be financed by such indebtedness.

39  
40 Notwithstanding anything in this Ordinance to the contrary, Tax Advantaged  
41 Obligations may be issued pursuant to Section 19-208 of the Local Government Article of  
42 the Annotated Code of Maryland (2013 Replacement Volume and 2025 Supplement) or  
43 any other laws of the State of Maryland authorizing the issuance thereof and may be sold  
44 for a price at, above or below par, plus accrued interest to the date of delivery. Authority  
45 is hereby conferred on the County Executive, or the Chief Administrative Officer if  
46 authorized by the County Executive, to sell any such Tax Advantaged Obligations through  
47 a public sale or through a private (negotiated) sale, without solicitation of competitive bids,  
48 as the County Executive, or the Chief Administrative Officer if authorized by the County  
49 Executive, upon consultation with the Controller and the County's financial advisor, shall

1 determine to be in the best interests of the County. Any sale of Tax Advantaged Obligations  
2 hereunder by private negotiation is hereby determined to be in the County's best interest.  
3 Tax Advantaged Obligations issued hereunder are hereby specifically exempted from the  
4 provisions of Sections 19-205 and 19-206 of the Local Government Article of the  
5 Annotated Code of Maryland (2013 Replacement Volume and 2025 Supplement).

6  
7 It is recognized that the market for Tax Advantaged Obligations is evolving and that  
8 the issuance and sale from time to time of Tax Advantaged Obligations with one stated  
9 maturity may be the most practicable method for successfully accomplishing the sale of  
10 Tax Advantaged Obligations by the County. Accordingly, the County is hereby authorized  
11 to issue Tax Advantaged Obligations with a single stated maturity and to provide for an  
12 Installment Plan with respect to the payment of Tax Advantaged Obligations, such  
13 Installment Plan to be approved by an order of the County Executive. The Installment Plan  
14 shall provide for annual payments to a sinking fund account (the "Escrow Account") to be  
15 pledged or otherwise applied to the payment of the Tax Advantaged Obligations and to be  
16 held by a trust company or other banking institution, as trustee or escrow agent, such annual  
17 payments to commence not later than two years from the date of issuance of the Tax  
18 Advantaged Obligations. Amounts so deposited to the Escrow Account shall be invested  
19 and reinvested in direct obligations of, or obligations the principal of, and the interest on  
20 which, are guaranteed by, the United States of America, or in certificates of deposit or time  
21 deposits secured by direct obligations or obligations the principal of, and the interest on  
22 which, are guaranteed by, the United States of America. Each annual payment deposited  
23 to the Escrow Account under the Installment Plan shall be invested and reinvested in a  
24 manner determined by the County so as to provide for the payment of a portion of the stated  
25 principal amount of such Tax Advantaged Obligations and related interest, if any. The  
26 issuance and sale of Tax Advantaged Obligations as a single bond with one stated maturity  
27 and the establishment of an Installment Plan as herein described are hereby authorized  
28 notwithstanding the requirement in Section 2 of this Ordinance that bonds be issued as  
29 serial maturity bonds or term bonds having mandatory sinking fund requirements,  
30 beginning not later than the second anniversary of the date of issuance of such series.

31  
32 (8) Notwithstanding anything in this Ordinance to the contrary, it is confirmed that  
33 bond premium, consisting of net bond proceeds from the sale of bonds sold at a price above  
34 par, may be allocated for expenditure purposes permitted under provisions of federal  
35 income tax law pertaining to excludability of interest on the bonds from gross income or  
36 the tax status of Tax Advantaged Obligations, as applicable.

37  
38 SECTION 9. *And be it further enacted*, That, notwithstanding any other provisions of  
39 this Ordinance, in order (i) to comply with the bond registration requirements of, and to  
40 conform with, developing practices in the municipal bond market, including practices of  
41 bond registrars and paying agents, (ii) to facilitate generally the issuance and sale of general  
42 obligation bonds and bond anticipation notes by the County, including compliance with  
43 disclosure and similar requirements and (iii) insofar as possible, to simplify issuance  
44 procedures, the County Executive, or the Chief Administrative Officer if authorized by the  
45 County Executive, is hereby authorized (a) to apply the provisions of this Ordinance, (b) to  
46 make determinations and decisions required by this Ordinance, (c) to make such insertions,  
47 modifications and corrections to the form of bonds, the form of notes and the form of notice  
48 of sale authorized hereby, including modifications to the method of publication in  
49 connection with the redemption of any bonds and whether to require a good faith deposit

1 with respect to any award of any general obligation bonds and bond anticipation notes,  
2 (d) to enter into agreements on behalf of the County and (e) to take all and any other actions  
3 under this Ordinance in the manner and to the extent that the County Executive or the Chief  
4 Administrative Officer, as the case may be, may deem necessary or appropriate to  
5 accomplish the stated purposes, taking into account the recommendations of bond counsel  
6 and the financial advisor to the County, including the making of agreements to facilitate  
7 the foregoing.

8  
9 SECTION 10. *And be it further enacted*, That, the Budget Officer and the Controller  
10 are hereby designated as the authorized deputies of the Chief Administrative Officer for  
11 the purpose of authenticating any bonds or bond anticipation notes issued hereunder. In  
12 addition, the County Executive may deliver a written certificate at or prior to the time of  
13 the issuance of any bonds or bond anticipation notes issued hereunder designating such  
14 other person or persons as shall be deemed appropriate as an authorized deputy or deputies  
15 of the Chief Administrative Officer for the purpose of authenticating any bonds or bond  
16 anticipation note issued hereunder.

17  
18 SECTION 11. *And be it further enacted*, That the County is hereby authorized to  
19 borrow money and incur indebtedness otherwise authorized to be borrowed and incurred  
20 hereunder in the form of bonds or bond anticipation notes by obtaining a loan (a “Water  
21 Infrastructure Loan”) from the Maryland Water Infrastructure Financing Administration  
22 (the “Administration”) pursuant to and in accordance with Sections 9-1601 through  
23 9-1622, inclusive, of the Environment Article of the Annotated Code of Maryland (2014  
24 Replacement Volume and 2025 Supplement) (the “Act”). Such Water Infrastructure Loans  
25 may be obtained by the County hereunder from time to time. Any such Water Infrastructure  
26 Loan shall be evidenced by a loan agreement (a “Water Infrastructure Loan Agreement”)  
27 between the County and the Administration and a bond issued by the County (a “Water  
28 Infrastructure Bond”).

29  
30 It is acknowledged that the proceeds of any Water Infrastructure Loan will be used for  
31 the public purposes of financing a portion of the costs of acquiring, constructing and  
32 equipping certain wastewater facilities or water supply systems, each as defined in the Act  
33 (collectively, the “Water Infrastructure Facilities”), including the development of property,  
34 the acquisition and installation of equipment and furnishings and any architectural,  
35 financial, legal, planning and engineering expenses. It is intended that the proceeds of any  
36 Water Infrastructure Loan undertaken by the County pursuant to this Section 11 may be  
37 expended on the applicable Water Infrastructure Facility and any related costs, including  
38 costs of the Administration and the funding of reserves, to the extent permitted by the Act  
39 and to the extent provided in the applicable Water Infrastructure Loan Agreement or Water  
40 Infrastructure Bond. It is acknowledged that Water Infrastructure Facilities as defined  
41 above may include projects that the County classifies as wastewater projects, water projects  
42 or under some other classification.

43  
44 Unless otherwise provided in this Section 11, limitations, procedures or requirements  
45 set forth in this Ordinance for the issuance, sale and delivery of bonds or bond anticipation  
46 notes, as applicable, to the extent practicable, shall apply to obtaining any Water  
47 Infrastructure Loan and to the execution and delivery of any Water Infrastructure Loan  
48 Agreement or Water Infrastructure Bond.

1 The County Executive, or the Chief Administrative Officer if authorized by the County  
2 Executive, is hereby authorized to approve the form of any Water Infrastructure Loan  
3 Agreement or Water Infrastructure Bond, the terms thereof, including the interest rate,  
4 maturity schedule, redemption provisions and covenants to be set forth therein, and the  
5 manner of executing and authenticating the same. The form of Water Infrastructure Bond  
6 need not conform to the forms otherwise provided in this Ordinance.

7  
8 Notwithstanding any other provision to the contrary in this Ordinance:

9  
10 (a) Any Water Infrastructure Loans (including any Water Infrastructure Loan  
11 Agreements and Water Infrastructure Bonds) need not be in denominations of \$5,000 or  
12 any integral multiple thereof, nor in a serial maturity format, provided, however,  
13 borrowings and evidences thereof shall be on an installment basis with annual principal  
14 payments beginning not more than two years from the date of issue;

15  
16 (b) Any Water Infrastructure Loan (including any Water Infrastructure Loan  
17 Agreement and Water Infrastructure Bond) may be sold at less than par and without regard  
18 to any limitation set forth in Section 2(1) hereof or Section 6(7) hereof, as applicable;

19  
20 (c) Any Water Infrastructure Loan (including any Water Infrastructure Loan  
21 Agreement and Water Infrastructure Bond) may provide for interest payments on other  
22 than a semiannual basis;

23  
24 (d) Paying agents and registrars may be provided for in the discretion of the County  
25 Executive, or the Chief Administrative Officer if authorized by the County Executive;

26  
27 (e) The County is hereby authorized to sell any Water Infrastructure Loan (including  
28 any Water Infrastructure Loan Agreement and Water Infrastructure Bond) at private  
29 (negotiated) sale to the Administration, public advertisement and sale of the same not being  
30 required by the terms of the Act and the best interests of the County being hereby declared  
31 to be served by such private sale;

32  
33 (f) Provisions for the redemption of any Water Infrastructure Loan (including any  
34 Water Infrastructure Loan Agreement and Water Infrastructure Bond) may be provided for  
35 in the discretion of the County Executive, or the Chief Administrative Officer if authorized  
36 by the County Executive; and

37  
38 (g) Any signature required in connection with the issuance and sale of any Water  
39 Infrastructure Loan (including any Water Infrastructure Loan Agreement and Water  
40 Infrastructure Bond) may be manual and any affixing of the County Seal may be  
41 accomplished by impressing the same on the applicable document.

42  
43 The County Executive, or the Chief Administrative Officer if authorized by the County  
44 Executive, is hereby authorized to take any and all actions in the manner and to the extent  
45 that the County Executive or the Chief Administrative Officer, as the case may be, may  
46 deem necessary or appropriate to accomplish the purposes of this Section.

1 Any Water Infrastructure Loan (including any Water Infrastructure Loan Agreement  
2 and Water Infrastructure Bond) shall be secured as provided in Section 2(6) of this  
3 Ordinance.

4  
5 With respect to any Water Infrastructure Loan authorized by this Section or by similar  
6 authority contained in a prior ordinance of the County, the County Executive, or the Chief  
7 Administrative Officer if authorized by the County Executive, may, in accordance with  
8 Paragraph (4) of Section II of the FINDINGS OF FACT, apply to any project authorized  
9 to be financed with a Water Infrastructure Loan the balance remaining to the credit of any  
10 completed or abandoned project previously financed with the proceeds of a Water  
11 Infrastructure Loan. In exercising such authority, the County Executive, or the Chief  
12 Administrative Officer if authorized by the County Executive, may enter into such  
13 amendments of Water Infrastructure Loan Agreements and related documents as deemed  
14 necessary or appropriate in the exercise of the authority granted hereby. In lieu of applying  
15 the balance of remaining to the credit of any completed or abandoned project financed with  
16 a Water Infrastructure Loan to new or additional projects, the County Executive, or the  
17 Chief Administrative Officer if authorized by the County Executive, may determine to  
18 prepay or otherwise effect a reduction in the stated principal amount or permitted maximum  
19 principal amount of any such Water Infrastructure Loan as permitted in the Water  
20 Infrastructure Loan Agreement and the Water Infrastructure Bond or as otherwise  
21 permitted and, in connection therewith, may take such action and make such amendments  
22 to the Water Infrastructure Loan Agreement and Water Infrastructure Bond as deemed  
23 necessary or appropriate to permit the reamortization of the principal amount outstanding  
24 and to effect such prepayment or reduction in stated principal amount.

25  
26 Following the execution and delivery of any written commitment specifying the  
27 material terms of any Water Infrastructure Loan, or if no such written commitment is  
28 entered into, following the execution and delivery of any Water Infrastructure Loan  
29 (including any Water Infrastructure Loan Agreement and Water Infrastructure Bond), the  
30 County Executive, or the Comptroller, if authorized by the County Executive, shall report  
31 the terms thereof in writing at the next meeting of the County Council.

32  
33 SECTION 12. *And be it further enacted*, That the County is hereby authorized to  
34 borrow money and incur indebtedness for shore erosion control projects hereinafter  
35 specified by obtaining a loan (a “Shore Erosion Control Construction Loan”) from the  
36 Shore Erosion Control Construction Loan Fund pursuant to and in accordance with  
37 Sections 8-1001 through 8-1008, inclusive, of the Natural Resources Article of the  
38 Annotated Code of Maryland (2023 Replacement Volume and 2025 Supplement) (the “Soil  
39 Erosion Control Act”). Each Shore Erosion Control Construction Loan shall be evidenced  
40 by a loan agreement (a “Shore Erosion Control Construction Loan Agreement”) between  
41 the County and the Department of Natural Resources (“DNR”) in a form determined by  
42 order of the County Executive, or the Chief Administrative Officer if authorized by the  
43 County Executive, as hereinafter provided. The authorization to borrow money and incur  
44 indebtedness pursuant to this Section 12 shall not be exercised unless and until  
45 appropriation is made for the expenditure of the proceeds of any such loan for the project  
46 to be financed thereby.

47  
48 Shore Erosion Control Construction Loans may be repaid from benefit charges levied  
49 on benefited property and may be further secured by a pledge of the full faith and credit of

1 the County, as determined by order of the County Executive, or the Chief Administrative  
2 Officer if authorized by the County Executive, as hereinafter provided. It is acknowledged  
3 and declared that the levy of any ad valorem taxes by the County to provide for repayment  
4 of the Shore Erosion Control Construction Loans shall be subject to the limitation on the  
5 tax levy set out in Section 710(d) of the County Charter.

6  
7 Pursuant to and in accordance with requirements of this Ordinance and the Shore  
8 Erosion Control Act, the County Executive by order is hereby authorized to approve the  
9 form of any Shore Erosion Control Construction Loan Agreement, the terms thereof,  
10 including the source or sources of and security for repayment, the repayment schedule and  
11 covenants to be set forth therein, and the manner of executing and authenticating the same.  
12 Pursuant to Section 8-1005(f) of the Soil Erosion Control Act, the County may borrow  
13 interest-free funds and repay the funds at a uniform rate over a period not exceeding  
14 25 years.

15  
16 The County Executive, or the Chief Administrative Officer if authorized by the County  
17 Executive, is hereby authorized to take any and all actions in the manner and to the extent  
18 that the County Executive or the Chief Administrative Officer, as the case may be, may  
19 deem necessary or appropriate to accomplish the purposes of this Section.

20  
21 Without limitation, Shore Erosion Control Construction Loan Agreements by and  
22 between the County and DNR heretofore approved are hereby approved and ratified,  
23 subject to reductions in loan amounts made in accordance with the respective loan  
24 agreements, as obligations of the County without further action.

25  
26 SECTION 13. *And be it further enacted,* That pursuant to the authority granted by  
27 Section 19-103 of the Local Government Article of the Annotated Code of Maryland (2013  
28 Replacement Volume and 2025 Supplement), the County Executive, or the Chief  
29 Administrative Officer if authorized by the County Executive, is hereby authorized in  
30 connection with the issuance of any bonds or notes hereunder to (i) provide, covenant or  
31 agree that, in the event that sufficient funds for the timely payment when due of principal  
32 of or interest on bonds or notes issued pursuant to the authority of this Ordinance are not  
33 available or in the event of a default in the payment of the principal of or interest on such  
34 bonds or notes, the first general fund revenues of the County received thereafter shall be  
35 applied to the payment when due of such principal or interest or to cure such default, as the  
36 case may be, and (ii) pledge any of the County's revenues to the payment of the principal  
37 of and interest on the bonds and notes issued pursuant to the authority of this Ordinance.  
38 In the event that the County Executive, or the Chief Administrative Officer if authorized  
39 by the County Executive, determines to exercise all or any part of the authority granted  
40 under this Section, the County Executive, or the Chief Administrative Officer if authorized  
41 by the County Executive, shall determine the form, terms and provisions of any order,  
42 certificate, agreement or related documents as shall be deemed necessary or appropriate to  
43 evidence any agreement or pledge authorized hereby, including (without limitation) terms  
44 and provisions regarding the application of such pledge or agreement to borrowings of the  
45 County other than bonds or notes issued pursuant to the authority of this Ordinance. Any  
46 such order, certificate, agreement or related document shall be executed by the County  
47 Executive and the seal of the County shall be impressed thereon, attested by the County  
48 Executive, the Secretary to the County Executive, the Administrative Officer to the County  
49 Council or such other officer as may be specified by ordinance of the County Council.

1 SECTION 14. *And be it further enacted*, That, as determined and specified in a  
2 certificate of the County Executive, or of the Chief Administrative Officer if authorized by  
3 the County Executive, executed and delivered prior to the issuance of bonds or notes, such  
4 bonds or notes may be issued to provide for the financing of one or more projects included  
5 within a specified class of projects set forth in Exhibit I. In addition, the amount of proceeds  
6 allocated to projects included within a specified class of projects financed by any issuance  
7 of bonds or notes may be amended after the issuance of such bonds or notes, as determined  
8 and specified in a certificate of the County Executive, or of the Chief Administrative  
9 Officer if authorized by the County Executive.

10  
11 In connection with the foregoing, the County Executive, or the Chief Administrative  
12 Officer if authorized by the County Executive, shall execute a certificate demonstrating or  
13 determining, as applicable:

14  
15 (a) That all bonds or notes are payable within the probable useful life of the  
16 improvement or undertaking being financed or, if the bonds or notes are to be issued for  
17 several improvements or undertakings, then within the average probable useful life of all  
18 such improvements or undertakings being financed;

19  
20 (b) That the amount of bonds or notes to be applied to any project to be financed  
21 shall not exceed the maximum amount set forth in Exhibit I authorized for such project;  
22 and

23  
24 (c) Such other matters as the County Executive or the Chief Administrative Officer  
25 (as the case may be) deems appropriate to establish compliance with the provisions of the  
26 County Charter and this Ordinance in connection with the issuance of bonds and notes to  
27 provide for the financing of one or more projects included within a specified class or to  
28 provide for the amendment of the list of projects from the specified class of projects  
29 financed by an issuance of bonds or notes, as described above.

30  
31 SECTION 15. *And be it further enacted*, That, subject to the following paragraphs of  
32 this Section 15, the authority to issue bonds under Bill No. 55-25, as amended, effective  
33 September 7, 2025 (“Bill No. 55-25”) is hereby canceled, rescinded and repealed, but only  
34 to the extent that such authority has not been exercised prior to the effective date of this  
35 Ordinance.

36  
37 Appropriate reductions shall be recognized in the amounts of bonds authorized for  
38 issuance under this Ordinance for bonds issued after May 31, 2026, under the authority of  
39 Bill No. 55-25, for projects authorized to be financed by Bill No. 55-25 and also authorized  
40 to be financed under this Ordinance and for refunding purposes authorized to be financed  
41 by Bill No. 55-25 and also authorized to be financed under this Ordinance.

42  
43 Nothing contained in this Ordinance shall be construed as impairing the validity of any  
44 proceedings or action taken, or the validity of any bonds or bond anticipation notes issued,  
45 or Shore Erosion Control Construction Loan Agreements executed, prior to the effective  
46 date of this Ordinance, under the provisions of Bill No. 55-25, or under prior bond  
47 authorization ordinances, and the authorization, sale and issuance of all bonds and bond  
48 anticipation notes issued prior to the effective date of this Ordinance pursuant to the  
49 authority of such ordinances, including (without limitation) the various series of general

1 obligation bonds and bond anticipation notes of the County set forth in Section 10 of Bill  
2 No. 57-08, Exhibit V of Bill No. 51-09, Exhibit V of Bill No. 53-10, Exhibit V of Bill No.  
3 52-11, Exhibit V of Bill No. 60-12, Exhibit V of Bill No. 63-13, Exhibit V of Bill No.  
4 55-14, Exhibit V of Bill No. 80-15, Exhibit V of Bill No. 46-16, Exhibit V of Bill No.  
5 60-17, Exhibit V of Bill No. 62-18, Exhibit V of Bill No. 51-19, Exhibit V of Bill No.  
6 47-20, Exhibit V of Bill No. 57-21, Exhibit V of Bill No. 58-22, Exhibit V of Bill No.  
7 51-23, Exhibit V of Bill No. 58-24, Exhibit V of Bill No. 55-25 and, in addition, the  
8 indebtedness set forth in Exhibit V attached hereto and incorporated herein (the “Prior  
9 Obligations”), and all such Prior Obligations be and they are hereby ratified and confirmed,  
10 together with all and several of the terms thereof and the action taken in connection with  
11 the issuance, sale and delivery thereof, are hereby validated as being validly authorized,  
12 sold, issued and executed, as applicable, and delivered by the County. The ratification of  
13 the Prior Obligations as set forth above shall be effective notwithstanding noncompliance  
14 with any provisions of the aforementioned ordinances that provide general fiscal or  
15 budgetary guidelines, such as provisions directing that specified portions of the Prior  
16 Obligations be issued during certain fiscal years.

17  
18 The validity of the revolving loan notes authorized to be issued pursuant to the Master  
19 Note Order adopted by the County Executive on December 18, 2014 (as amended or  
20 supplemented from time to time, the “Note Order”) and designated as the County’s “Master  
21 General Obligation Bond Anticipation Note, Series A (Consolidated General  
22 Improvements Series),” “Master General Obligation Bond Anticipation Note, Series B  
23 (Consolidated Water and Sewer Series),” and “Master General Obligation Bond  
24 Anticipation Note, Series C (Consolidated Solid Waste Projects Series - AMT)”  
25 (collectively, the “Master Notes”), and all related documents, such as a revolving credit  
26 agreement (the “Revolving Loan Documents”) executed and delivered prior to the effective  
27 date of this Ordinance shall not be impaired in any manner by the passage of this  
28 Ordinance, and such Master Notes and Revolving Loan Documents executed and delivered  
29 in connection with the Master Notes are hereby ratified and confirmed. Bond anticipation  
30 notes authorized by this Ordinance may be evidenced by advances under the Revolving  
31 Loan Documents in the amount and in the manner set forth in the Note Order.

32  
33 Bonds and bond anticipation notes may be issued under this Ordinance to pay bond  
34 anticipation notes issued pursuant to and in accordance with a note order or credit  
35 agreement provided that such bonds or bond anticipation notes are authorized to be issued  
36 hereunder for projects financed by such bond anticipation notes issued pursuant to and in  
37 accordance with the note order or credit agreement.

38  
39 SECTION 16. *And be it further enacted*, That, if any one or more of the provisions of  
40 this Ordinance, including any covenants or agreements provided herein on the part of the  
41 County to be performed, should be contrary to law, then such provision or provisions shall  
42 be null and void and shall in no way affect the validity of the other provisions of this  
43 Ordinance or of the bonds or the bond anticipation notes issued hereunder.

44  
45 SECTION 17. *And be it further enacted*, That, this Ordinance shall take effect 45 days  
46 from the date it becomes law.
