1 RESOLUTION confirming the appointment of a professional fire fighter who is a
2 member of the classified service to serve on the Pension Oversight Commission for Anne
3 Arundel County

5 WHEREAS, Section 606(a) of the Charter provides that there shall be a Pension
6 Oversight Commission that is independent of both the legislative and executive
7 branches of the County government; and

9 WHEREAS, Section 606(b)(1) of the Charter provides that the Pension Oversight
10 Commission shall consist of nine members appointed by the County Executive and
11 confirmed by resolution of the County Council; and

12
13 WHEREAS, Section 606(b)(3) of the Charter provides that one member shall be a
14 professional fire fighter and is selected from a list of members of the classified
15 service nominated by secret ballot by members of the classified service; and

16
17 WHEREAS, Section 606(c)(1) of the Charter provides that the term of a member
18 shall be four years; and

19
20 WHEREAS, Section 606(c)(4) of the Charter provides that a person may not serve
21 for more than two terms as a member of the Pension Oversight Commission; and

23 WHEREAS, the term of the professional fire fighter who is a member of the
24 classified service has expired; and

25
26 WHEREAS, the County Executive, subject to confirmation by the County Council,
27 has appointed classified service member Steven Orlosky (a professional fire fighter
28 who is a member of the classified service) to a term commencing on July 1, 2026,
29 and expiring on June 30, 2030; and

31 WHEREAS, the County Council finds that Steven Orlosky meets the eligibility
32 requirements under Section 606(b)(3) of the Charter and is qualified to serve on the
33 Pension Oversight Commission; now, therefore, be it

35 *Resolved by the County Council of Anne Arundel County, Maryland, That it hereby*
36 *approves the appointment to the Pension Oversight Commission of Steven Orlosky (a*
37 *professional fire fighter who is a member of the classified service) to an initial term*
38 *commencing on July 1, 2026, and expiring on June 30, 2030; and be it further*
