1 RESOLUTION approving appointments to the Board of Trustees for the Anne Arundel  
2 County Retirement and Pension System

3  
4 WHEREAS, § 5-2-104 of the Anne Arundel County Code provides that there is a  
5 Board of Trustees for the Anne Arundel County Retirement and Pension System;  
6 and

7  
8 WHEREAS, § 5-2-105(a)(7) of the Anne Arundel County Code provides that three  
9 of the Trustees shall be residents of the County, may not be employees of the  
10 County, may not be participants in any of the retirement or pension plans governed  
11 by the Board of Trustees, and shall be knowledgeable in the administration and  
12 operation of pension systems and trust funds; and

13  
14 WHEREAS, § 5-2-105(c) of the Anne Arundel County Code provides that these  
15 three Trustees shall be appointed by the County Executive with the approval of the  
16 County Council, given by resolution; and

17  
18 WHEREAS, § 5-2-105(e) of the Anne Arundel County Code provides that these  
19 three Trustees shall serve terms of three years; and

20  
21 WHEREAS, Mary Lu Hughes completed a term as one of the three Trustees  
22 described in § 5-2-105(a)(7) on April 30, 2023, and has continued to serve because  
23 no successor has been appointed; and

24  
25 WHEREAS, Mary Kathleen Sulick completed a term as one of the three Trustees  
26 described in § 5-2-105(a)(7) on April 30, 2024, and has continued to serve because  
27 no successor has been appointed; and

29 WHEREAS, Alan J. Hyatt completed a term as one of the three Trustees described  
30 in § 5-2-105(a)(7) on December 1, 2024, and has continued to serve because no  
31 successor has been appointed; and

33 WHEREAS, the County Executive, subject to the approval of the County Council,  
34 has: (1) reappointed Mary Lu Hughes to a term beginning on May 1, 2026, and  
35 expiring on April 30, 2029; (2) reappointed Mary Kathleen Sulick to the remainder  
36 of a term expiring on April 30, 2027; and (3) reappointed Alan J. Hyatt to the  
37 remainder of a term expiring on December 1, 2027; and

1 WHEREAS, the County Council finds that Mary Lu Hughes, Mary Kathleen  
2 Sulick, and Alan J. Hyatt meet the eligibility requirements under § 5-2-105 of the  
3 Anne Arundel County Code, and are qualified to serve on the Board of Trustees;  
4 now, therefore, be it

5  
6 *Resolved by the County Council of Anne Arundel County, Maryland,* That it hereby  
7 approves the reappointment of: (1) Mary Lu Hughes to a term beginning on May 1, 2026,  
8 and expiring on April 30, 2029; (2) Mary Kathleen Sulick to the remainder of a term  
9 expiring on April 30, 2027; and (3) Alan J. Hyatt to the remainder of a term expiring on  
10 December 1, 2027; and be it further

11  
12 *Resolved,* That a copy of this Resolution be sent to Steuart Pittman, County Executive;  
13 Mary Lu Hughes, Trustee; Mary Kathleen Sulick, Trustee; Alan J. Hyatt, Trustee; and  
14 Christine Anderson, Chair, Board of Trustees for the Anne Arundel County Retirement  
15 and Pension System.


