1 AN ORDINANCE concerning: Construction and Property Maintenance Codes –
2 International Swimming Pool and Spa Code – Barrier Requirements

4 FOR the purpose of removing the exemption to certain barriers for pools with powered
5 safety covers; and generally relating to construction and property maintenance codes.

7 BY renumbering: International Swimming Pool and Spa Code Amendments, Items (3)
8 through (6) to be International Swimming Pool and Spa Code Amendments, Items (4)
9 through (7)
10 Anne Arundel County Construction and Property Maintenance Codes Supplement,
11 October 1, 2005 (as amended)

13 BY adding: International Swimming Pool and Spa Code Amendments, Item (3)
14 Anne Arundel County Construction and Property Maintenance Codes Supplement,

17 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
18 That International Swimming Pool and Spa Code Amendments, Items (3) through (6),
19 respectively, Anne Arundel County Construction and Property Maintenance Codes
20 Supplement, October 1, 2005 (as amended), are hereby renumbered to be International
21 Swimming Pool and Spa Code Amendments, Items (4) through (7), respectively.

23 SECTION 2. That the Anne Arundel County Construction and Property Maintenance
24 Codes Supplement, October 1, 2005 (as amended) read as follows:

5 **INTERNATIONAL SWIMMING POOL AND SPA CODE AMENDMENTS**

7 The provisions of the 2021 International Swimming Pool and Spa Code are amended,
8 deleted, or corrected as follows and the following provisions shall supersede the part of the
9 text of the 2021 International Swimming Pool and Spa Code as indicated:

11 (3) IN SECTION 305.1, IN THE SECOND SENTENCE, STRIKE FROM “AND” THROUGH
12 “F1346”, STRIKE THE COMMA AFTER “SPAS” AND SUBSTITUTE “OR”, AND STRIKE “OR
13 POOLS”.

15 SECTION 3. *And be it further enacted*, That this Ordinance shall take effect 45 days
16 from the date it becomes law.
