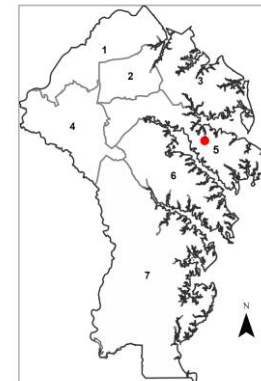

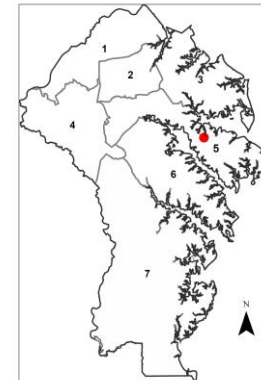

This project would seek state and county funding support and construct a new space and relocate the HCAT program from Glen Burnie to the Arnold campus at a cost to the county comparable the current estimates to attempt another round of remediation.

Benefit

The HCAT facility located in Glen Burnie has experienced significant settlement issues since it was originally renovated in 2001. The building, which includes instructional kitchens, several classrooms, office, and storage areas has had numerous studies, inspections, and remediation actions taken to evaluate and correct the settlement issue. However, the issues continue to plague the facility. The new facility will reallocate all HCAT functions into a single facility on the Arnold campus.

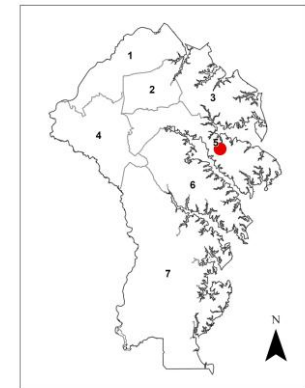

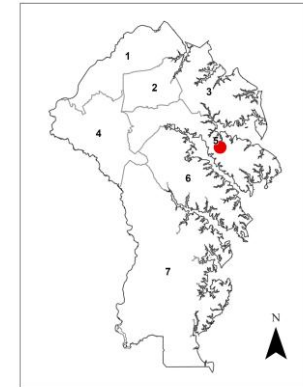
