Capital Budget and Program – Town Center to Reece  
Road and Culvert Invert Paving Capital Projects –  
Transfer of Appropriations

Dear County Executive Pittman:

The Planning Advisory Board (PAB) is a citizen advisory board created by §532 of the Anne Arundel County Charter. Under § 533 of the Charter, the PAB is charged with recommending the list of capital projects, along with their estimated costs, to be implemented by the County. Also under § 533, the PAB considers and transmits advisory recommendations for amendments to the Capital Budget to the County Executive through the course of the year.

The PAB met on August 26, 2026 and received an overview of Bill # 68-26 from the Office of Budget. This Ordinance is for the purpose of amending the Capital Budget for Fiscal Year 2027. The request is to transfer \$1.4 Million from the Town Center to Reece Road capital project (H371200) to the Culvert Invert Paving capital project (H590000). This request will provide funds to complete urgent repairs to a culvert on Hospital Drive in Glen Burnie. Overall, the requests will result in a net \$0 change to the FY27 Capital Budget and Program.

Following the presentation and discussion among the members of the PAB, the Board voted 5-0 to offer an advisory recommendation of approval of Bill # 68-26.
